## **By-Law Number 13 - 2021**

## A By-Law to Provide for Annual Remuneration for the years 2021 and 2021 to the Mayor and Members of Council of the Corporation of the City of Kenora

Whereas Section 283(1) of The Municipal Act, S.O. 2001, c. 25, as amended, provides for payment of remuneration to the Head and Members of Council; and

Whereas Section 283 (4) of The Municipal Act 2001, S.O. 2001, c.25 no part of the remuneration of a member of a Council or local board paid under this section is deemed to be for expenses incidental to his or her duties as a member and a municipality or local board shall not provide that any part of the remuneration is for such deemed expenses;

Now Therefore the Council of the Corporation of the City of Kenora enacts as follows:~

- 1. That the economic adjustment that was approved for City non-union staff for 2020 was 2%, approved at the January 28, 2020 Council meeting;
- 2. As per City policy #CC-15-1 a corresponding adjustment of 2% is now hereby authorized to establish a like increase for Council remuneration;
- 3. That for the year 2020 the annual remuneration of the Head of Council shall be Thirty Nine Thousand and Four Hundred and Sixty Dollars (\$39,461.00);
- 4. That for the year 2020 annual remuneration of Members of Council shall be Nineteen Thousand, Eight Hundred and Two Dollars (\$19,802.00) per annum;
- 5. That for the year 2020 the per diem rate be paid to the Head of Council and Members of Council in the amount of \$191.00 and includes travel days. If four (4) hours or less in duration then 50% of this approved rate shall be paid;
- 6. That the economic adjustment that was approved for City non-union staff for 2021 was 1.5%, approved at the January 19, 2021 Council meeting;
- 7. As per City policy #CC-15-1 a corresponding adjustment of 1.5% is now hereby authorized to establish a like increase for Council remuneration;
- 8. That for the year 2021 the annual remuneration of the Head of Council shall be Forty Thousand and Fifty Three Dollars (\$40,053.00);
- 9. That for the year 2021 annual remuneration of Members of Council shall be Twenty Thousand and Ninety Nine Dollars (\$20,099.00) per annum;
- 10. That for the year 2021 the per diem rate be paid to the Head of Council and Members of Council in the amount of \$194.00 and includes travel days. If four (4) hours or less in duration then 50% of this approved rate shall be paid;

- 11. That any other honorariums may be paid to the Head of Council or Members of Council for serving on other Boards, Committees or Commissions, in accordance with City Policy;
- 12. That all other associated expenses, i.e. travel, meal allowance, out of City mileage, etc. shall be paid in accordance with City Policy.
