## By Law Number 157 - 2024

### A By-law to amend By-Law Number 38-2024 being a By-law to Regulate Traffic and Parking in the City of Kenora

Whereas the Council of the City of Kenora adopted By-law Number 38-2024 on the 19th day of November, 2024; and

Whereas it is deemed necessary to amend the By-law to accommodate changing requirements;

Now therefore be it resolved that the Council of the City of Kenora enacts as follows:-
