BY-LAW NUMBER 6-2001

A BY-LAW TO ASSUME, STOP UP, CLOSE AND SELL THAT PART OF THE ROAD ALLOWANCE IN FRONT OF BROKEN LOT 2, CONCESSION 7, TOWNSHIP OF JAFFRAY, NOW CITY OF KENORA, IN THE DISTRICT OF KENORA, DESIGNATED AS PART 2 ON PLAN 23R-10427 TO PETER MICHAEL KINGER AND TANNIS MARIE SVEINSSON

WHEREAS the Council of the Corporation of the City of Kenora, deems it necessary and expedient to assume, stop up, close and sell part of the road allowance in front of Broken Lot 2, Concession 7, in the Township of Jaffray, now the City of Kenora, in the District of Kenora, being designated as Part 2 on Plan 23R-10427.

WHEREAS the Corporation of the City of Kenora has identified Part 2 on Plan 23R-10427 as surplus land and reached an Agreement with Peter Michael Kinger and Tannis Marie Sveinsson to sell the said lands;

NOW THEREFORE The Corporation of the City of Kenora enacts as follows:

1. **THAT** part of the road allowance, described as follows:

Part of the road allowance in front of Broken Lot 2, Concession 7, Township of Jaffray, now the City of Kenora, in the District of Kenora, and being designated as **PART 2 on PLAN 23R-10427** be and the same is hereby assumed, stopped up and closed.

- 2. **THAT** the Corporation of the City of Kenora shall sell to Peter Michael Kinger and Tannis Marie Sveinson part of the road allowance designated as Part 2 on Plan 23R-10427, Township of Jaffray, now City of Kenora, in the District of Kenora, for the sum of ONE THOUSAND (\$1,000.00) DOLLARS plus 7% GST, for a total consideration of \$1,070.00
- 3. **THAT** the Purchasers undertake and agree to pay all costs pertaining to a survey (as required) and costs of advertising, preparation and registration of the Transfer/Deed of Land and all the related legal and transfer documentation.
- 4. **THAT** the Mayor and the Clerk be and they are hereby empowered to execute documents in connection with the assuming, stopping up, closing and selling of the hereinbefore mentioned lands.
- 5. **THAT** this By-Law shall come into force and be in effect from and after the final passing thereof.
