WHEREAS the Council of the Corporation of the City of Kenora, deems it necessary and expedient to sell part of the road allowance in front of Mining Location A-16, now Block C, Plan M.33, Town of Kenora, now the City of Kenora, in the District of Kenora, being designated as Parts 1 and 2 on Plan 23R-10480.

WHEREAS the Corporation of the City of Kenora has identified Parts 1 and 2 on Plan 23R-10480 as surplus land and reached an Agreement with Laurene A. Manson and Ross G. Sillery to sell the said lands;

NOW THEREFORE The Corporation of the City of Kenora enacts as follows:

1. **THAT** part of the road allowance, described as follows:

Part of the road allowance in front of Mining Location A-16, now Block C. Plan M.33, Town of Kenora, now the City of Kenora, in the District of Kenora, and being designated as **PARTS 1 AND 2 on PLAN 23R-10480**

be and the same is hereby declared as surplus land.

- 2. **THAT** the Corporation of the City of Kenora shall sell to Laurene A. Manson and Ross G. Sillery the road allowance designated as Parts 1 and 2 on Plan 23R-10480, Town of Kenora, now City of Kenora, in the District of Kenora, for the sum of SEVEN HUNDRED AND FIFTY (\$750.00) DOLLARS plus 7% GST, for a total consideration of \$802.50
- 3. **THAT** the Purchasers undertake and agree to pay all costs pertaining to a survey (as required) and costs of advertising, preparation and registration of the Transfer/Deed of Land and all the related legal and transfer documentation.
- 4. **THAT** the Mayor and the Clerk be and they are hereby empowered to execute documents in connection with the assuming, stopping up, closing and selling of the hereinbefore mentioned lands.
- 5. **THAT** this By-Law shall come into force and be in effect from and after the final passing thereof.
