**BY-LAW NUMBER 78-2002**

**A BY-LAW TO AUTHORIZE THE TEMPORARY CLOSING  
OF CERTAIN MUNICIPAL STREETS FOR THE PURPOSE  
OF CONDUCTING VARIOUS SUMMER EVENTS AT THE HARBOURFRONT FOR THE 2002  
SEASON**

**WHEREAS** Section 297(9), of The Municipal Act, provides that a By-law may be passed for closing streets to vehicular traffic, on a temporary basis, for such period as shall be specified in the By-law, and Highway or portion of a Highway under the jurisdiction of the Council, for such social, recreational, community or athletic purposes, or combination of such purposes, as may be specified in the By-law.

**AND WHEREAS** such By-law may prohibit the use, except for pedestrian traffic, of the Highway or portion of the Highway so closed during the period of closure except under the authority of a permit issued under the By-law upon such terms and conditions, including such fee for the permit as may be set out in the By-law;

**NOW THEREFORE** the Council of the City of Kenora enacts as follows:-

**1.** That the use, except for pedestrian traffic, of those Highways at those times more particularly described and shown in Schedule "A" attached hereto, is hereby prohibited for **the following 2002 summer events taking place at the Harbourfront:~**

**a. HARBOURFEST**

- Bernier Drive from Lakeview Drive to Second St. S.; and First St. from Main St. to Bernier Drive, August 2, 2002, 6:00 p.m. to August 5, 2002, Midnight.

**b. KENORA BASS INTERNATIONAL**

- Bernier Drive from First St. to Second St. S. August 11, 2002, 6:00 a.m. to 8:00 p.m.

**2.** Notwithstanding the foregoing:

**(i)** where a permit has been issued to the Corporation of the City of Kenora, Ontario, persons participating in the program of events of the said Corporation of the City of Kenora, Ontario; and

**(ii)** police, fire, ambulance and public utility vehicles during an emergency, or where required to protect persons or property, may use the said portions of the Highway so closed during the period of closures.

**3.** Such permit may be issued upon application to the Issuer of Licences and such permit may take the form of a letter signed by the Issuer of Licences.

**4.** No fee shall be payable for such permit, but organizer must advertise said closure publicly.

**5.** Any person violating any of the provisions of this By-law shall be subject to penalty of not more than One Thousand Dollars (\$1,000.00), exclusive of costs, and all such penalties shall be recoverable under the Provincial Offences Act.

**6.** That this By-law shall take effect and come into force upon the third and final reading thereof.

**VARIOUS SUMMER EVENTS AT THE HARBOURFRONT FOR THE 2002 SEASON**

**a. HARBOURFEST**

- That area of the Harbourfront being Bernier Drive from Lakeview Drive to Second Street South; and First Street from Main St. to Bernier Drive, excluding the private and reserved parking areas, August 2, 2002, 6:00 p.m. to August 5, 2002 midnight.

**b. KENORA BASS INTERNATIONAL**

- That area of the Harbourfront being Bernier Drive from First Street to Second Street South, excluding the private and reserved parking areas, August 11, 2002, 6:00 a.m. to August 11, 2002, 8:00 p.m.
