BY-LAW NUMBER 119-2002

A BY-LAW TO AMEND BY-LAW NUMBER 127-2001 BEING A BY-LAW TO REGULATE TRAFFIC ON THE ROADS AND HIGHWAYS OF THE CITY OF KENORA

WHEREAS the Council of the City of Kenora adopted By-law Number 127-2001 on the 9th day of October, 2001; and

WHEREAS it is deemed necessary to amend the By-law to accommodate changing requirements;

NOW THEREFORE BE IT RESOLVED THAT the Council of the City of Kenora enacts as follows:-

1. That Schedule "B" is amended by changing the following.

AMEND:

NO PARKING AREAS - TOW AWAY ZONE**

Main Street South	From McClellan Avenue north for 8 metres	East	Anytime
McClellan Avenue	From 12.5 metres east of Hennepen Lane to 9 metres west of lane	North	Anytime

DELETE:

2 nd Street South	From Main Street South to Chipman Street	North	Anytime
------------------------------	--	-------	---------

ADD:

2 nd Street South	From Chipman Street to 19 metres west of Matheson Street South	North	Anytime
2 nd Street South	From 30 metres west of Matheson Street South to Main Street South	North	Anytime

ADD:

Main Street South	From 27.5 metres north of McClellan Avenue north for 11.5 metres	East	Anytime
McClellan Avenue	From 35 metres west of Hennepin Lane west to Main Street South	North	Anytime

2. That Schedule "G" is amended by changing the following:

ADD:

**SCHEDULE "G"
PARKING METER ZONES**

- TWO-HOUR METERS** - 50 cents per 60 minutes
- 25 cents per 30 minutes
- 10 cents per 12 minutes
- 5 cents per 6 minutes

Column 1 STREET	Column 2 PART OF STREET	Column 3 SIDE
2 nd Street South	From 19 metres west of Matheson Street South, westerly for 21 metres	North
McClellan Avenue	From 9 metres west of Hennepin Lane westerly for 26 metres	North

3. That this By-law shall take effect and come into force upon third and final reading thereof.
