BY-LAW NUMBER 8-2004

A BY-LAW TO AMEND BY-LAW NUMBER 127-2001 BEING A BY-LAW TO REGULATE TRAFFIC ON THE ROADS AND HIGHWAYS OF THE CITY OF KENORA

WHEREAS the Council of the City of Kenora adopted By-law Number 127-2001 on the 9th day of October, 2001; and

WHEREAS it is deemed necessary to amend the By-law to accommodate changing requirements;

NOW THEREFORE BE IT RESOLVED THAT the Council of the City of Kenora enacts as follows:-

1. Schedules O, P, R and T are hereby amended by changing the following:-

SCHEDULE "O" STOP SIGNS AT INTERSECTIONS:

Column 1 (Intersection)	Column 2 (Facing Traffic)
REMOVE: Coker Road and Beggs Road	South bound on Beggs Road
ADD: East Melick Road and Coker Road	East bound on Coker Road
ADD: Beggs Road and Loranger Road	West bound on Loranger Road
ADD: Beggs Road and Paquette's Road	West bound on Paquette's Road
ADD: Gunne Crescent and Poirier Drive	North bound on Gunne Crescent West bound on Gunne Crescent South bound on Poirier Drive
ADD: Peter Avenue and Kirkpatrick Avenue	North bound on Kirkpatrick Avenue

SCHEDULE "P" YIELD INTERSECTIONS:

Column 1 (Intersection)	Column 2 (Facing Traffic)
REMOVE: Gunne Crescent (West Leg) and 140 metres north of Valley Drive	North bound on Gunne Crescent

SCHEDULE "R" COMMUNITY SAFETY ZONES

Column 1 STREET	Column 2 LOCATION	Column 3 TIME	Column 4 PENALTY
Add: Gunne Crescent	All of Gunne Crescent	12:01 a.m. to 11:59 p.m. CST or CDST (whichever is currently in effect) 7 Days per Week All Year	Fines Increased

SCHEDULE "T" RATE OF SPEED

80 KILOMETRES PER HOUR ZONE

Column 1 STREET	Column 2 LOCATION	Column 3 MAXIMUM SPEED
Remove: Coker Road	From Redditt Road to East Melick Road	80 kilometres per hour

60 KILOMETRES PER HOUR ZONE

Column 1 STREET	Column 2 LOCATION	Column 3 MAXIMUM SPEED
Add: Coker Road	From Redditt Road to East Melick Road	60 kilometres per hour

40 KILOMETRES PER HOUR ZONE

Column 1 STREET	Column 2 LOCATION	Column 3 MAXIMUM SPEED
Add: Gunne Crescent	For its entire length	40 kilometres per hour
