Dear Sno-X Organizing Committee;

RE: City of Kenora & Sno X 2006

Your organization has requested that the 2006 Sno-X event be held at the Kenora Recreation Centre. The date of the event is March 3-5 2006. This event has been held at this venue in the past, and there were several issues with the venue. These issues were identified to Sno-X by the City of Kenora.

Over the course of several meetings with the City of Kenora, an agreement for the staging of the 2006 Sno-X event which will address past issues has been reached by both parties. The items included in the agreement are summarized as follows:

- (i) Sno-X event organizers will endeavour to haul clean snow to the Kenora Recreation Centre site to facilitate post-event clean up;
- (ii) the City of Kenora will haul snow from the south side of the City to the Kenora Recreation Centre staging site;
- (iii) Sno-X will ensure the City of Kenora is additional named insured for the amount of \$2 Million in liability insurance coverage for the Kenora Recreation Centre event site to cover the approximate time period from Feb 27-Mar 10 2006. Specifically, Sno-X will provide insurance coverage at the event site from the time Sno-X begins shaping the track, throughout the event and also post-event until the track is dismantled to the satisfaction of the City of Kenora;
- (iv) Sno-X will develop and implement a communications strategy to notify area residents of the event dates including posting notices at the Benedictson Court and throughout the Lakeside area;
- (v) Sno-X will be responsible for the repair of damages to bleachers, fences or other City infrastructure incurred during the event to the satisfaction of the City of Kenora;
- (vi) the City of Kenora shall provide assistance with the knock down of the track after the event;

- (vii) Sno-X shall work with the LOWBIC Special Events Coordinator to complete the Rec Centre Sno-X Clean Up Plan as attached to this letter to the satisfaction of the City of Kenora;
- (viii) the City of Kenora, Sno-X, and LOWBIC shall meet regularly before and after the event to ensure successful staging and clean up of the event:
- (ix) the City of Kenora and Sno-X will work together to identify a long term venue for this event.
