BY-LAW NUMBER 68-2006

A BY-LAW TO AMEND BY-LAW NUMBER 127-2001 BEING A BY-LAW TO REGULATE TRAFFIC ON THE ROADS AND HIGHWAYS OF THE CITY OF KENORA

WHEREAS the Council of the City of Kenora adopted By-law Number 127-2001 on the 9th day of October, 2001; and

WHEREAS it is deemed necessary to amend the By-law to accommodate changing requirements;

NOW THEREFORE BE IT RESOLVED THAT the Council of the City of Kenora enacts as follows:-

1. Schedule G be hereby amended by changing the following:-

SCHEDULE "G" PARKING METER ZONES:

HALF- HOUR METERS

Column 1 STREET	Column 2 PART OF STREET	Column 3 SIDE
Delete: 2 nd Street South	From 16 metres east of Park Street easterly for 20 metres	North

TWO-HOUR METERS

Column 1 STREET	Column 2 PART OF STREET	Column 3 SIDE
Add: 2 nd Street South	From 16 metres east of Park Street easterly for 20 metres	North

ONE-HOUR METERS - 50 cents per 60 minutes
- 25 cents per 30 minutes
- 10 cents per 12 minutes
- 5 cents per 6 minutes

Change to Read:

- ONE-HOUR METERS** – 75 cents per 60 minutes
- 25 cents per 20 minutes
- 10 cents per 8 minutes
- 5 cents per 4 minutes

* **Note:** \$1.00 coin, if used, will register 60 minutes.

- TWO-HOUR METERS** - 50 cents per 60 minutes
- 25 cents per 30 minutes
- 10 cents per 12 minutes
- 5 cents per 6 minutes

Change to Read:

- TWO-HOUR METERS** – \$1.00 coin per 80 minutes (1 hour 20 minutes)
- 75 cents per 60 minutes
- 25 cents per 20 minutes
- 10 cents per 8 minutes
- 5 cents per 4 minutes

* **Note:** \$2.00 coin, if used, will register 120 minutes.

- THREE-HOUR METERS** - 50 cents per 60 minutes
- 25 cents per 30 minutes
- 10 cents per 12 minutes
- 5 cents per 6 minutes

Change to Read:

- THREE-HOUR METERS** – \$2.00 coin per 160 minutes (2 hours 40 minutes)
- \$1.00 coin per 80 minutes (1 hour 20 minutes)
- 75 cents per 60 minutes
- 25 cents per 20 minutes
- 10 cents per 8 minutes
- 5 cents per 4 minutes

Add:

- FOUR-HOUR METERS** – \$2.00 coin per 160 minutes (2 hours 40 minutes)
- \$1.00 coin per 80 minutes (1 hour 20 minutes)
- 75 cents per 60 minutes
- 25 cents per 20 minutes
- 10 cents per 8 minutes
- 5 cents per 4 minutes

2. That this By-law shall take effect and come into force effective June 1, 2006.
