BY-LAW NUMBER 93 - 2009

A BY-LAW TO AMEND BY-LAW NUMBER 84-2006 BEING A BY-LAW TO ESTABLISH A REGISTER OF PROPERTY SITUATED IN THE MUNICIPALITY THAT IS OF CULTURAL HERITAGE VALUE OR INTEREST

WHEREAS Section 27(1) of the Ontario Heritage Act, as amended, requires that the clerk of a municipality shall keep a register of property situated in the municipality that is of cultural heritage value or interest; and

WHEREAS Council adopted By-law Number 84-2006 on the 12th of June, 2006; and

WHEREAS Heritage Kenora, being the Heritage Committee has recommended that certain properties be added to the municipal register; and

WHEREAS the Council of the Corporation of the City of Kenora deems it necessary and expedient to pass such a by-law for this purpose;

NOW THEREFORE be it resolved that the Council of the Corporation of the City of Kenora hereby enacts as follows:

1. THAT properties, or structures upon properties, described as:
 - i. Kenora Courthouse: 216 Water Street PLAN 3 BLK 1 LOT 20 TO 21
 - ii. Del-Art Manor: 102 Government Road, PT MILL LOCATION RP 23R4158;PARTS 2 3 4 PCL 29906
 - iii. Knox United Church: 116 Fifth Avenue S., PLAN 25 LOT 258 TO 259
 - iv. Best Western Lakeside Inn & Convention Centre: 470 First Avenue S., WATER LOT LOC KM186 RP;KR1446 PART 1 LEASEHOLD;PARCEL 3087
 - v. Keewatin Memorial Building: 102 Tenth Street, PART W PT BLK 57 PLAN 18;PLUS 2 S PT STRIP ADJ BLK 57;PCL 20362
 - vi. Moncrief Barn: 82 Redditt Road CON 7J PT LOT 4;RP23R 9070 PARTS 1 & 2;PCL 40758
 - vii. Stone House: 225 Main Street, PLAN 3 BLK 2 LOT 14 PT LOT;15

be and are recommended by the Kenora Heritage Committee as being of cultural value or interest and are hereby added to the register of property situated in the municipality;
