By-law Number 182 - 2010

A By-Law to Authorize the Execute An Extension to a Contract Agreement Between the Corporation of the City of Kenora and Jennifer Schott for the Operation and Maintenance of Coney Island Beach and Park

Whereas the Corporation of the City of Kenora deems it necessary to execute a Contract Agreement between The Corporation of the City of Kenora and Jennifer Schott to supply maintenance services for the operation of the park and concession of Coney Island Beach and Park;

Now Therefore the Council of the Corporation of the City of Kenora enacts as follows:

1. **THAT** this Contract Agreement shall be in effect for an extended one year period from May to September, 2011.
2. **That** this Contract remain at the equivalent amount as the 2010 pricing in the amount of \$11,000.00 plus applicable taxes.
3. **THAT** the Mayor and Clerk of the Corporation of the City of Kenora are hereby authorized to execute a Contract Agreement between the Corporation of the City of Kenora and Jennifer Schott for the maintenance and operation of Coney Island Beach and Park in accordance with the terms and conditions therein and affix the Seal of the Corporation thereto.
4. **THAT** this by-law shall come into force and be in effect from and after the final passing thereof.

Whereas the City is the owner of Coney Island Beach & Park located in the City of Kenora; and requires a contractor to supply maintenance services for the operation of the park and concession.

Whereas Schott had submitted a bid on a Request for Tender in 2008 to supply labour, material, equipment and services to operate and maintain the Coney Island Beach & Park for a 2 year period in accordance with the Tender Documents.

Now Therefore This Contract Agreement Witnesseth that in consideration of the premises noted below, the parties hereto covenant and agree as follows:

1. **That** Schott will provide operation and maintenance services in accordance with the contract documents and submitted tender form from the 2008 contract for an additional one year period ending September, 2011.
2. **That** this agreement is not transferable.
3. **That** this agreement shall take effect and come into force on September 22, 2010.
