

# The Corporation of the City Of Kenora

## By-Law Number 109 - 2011

### A By-Law to Assume, stop up, close and sell that part of Lane between Lots 5, 6 & 7, Block 11, Plan 18, Town of Keewatin, now City of Kenora, District of Kenora

**Whereas** the Corporation of the City of Kenora deems it necessary and expedient to assume, stop up, close and sell part of the Lane between Lots 5, 6 & 7, Block 11, Plan 18, Town of Keewatin, now City of Kenora, District of Kenora, designated as Part 1, Plan 23R12015; and

**Whereas** the Corporation of the City of Kenora has identified part of the Lane between Lots 5, 6 & 7, Block 11, Plan 18, Town of Keewatin, now City of Kenora, District of Kenora, designated as Part 1, Plan 23R12015 as surplus land and has reached an Agreement with Emile Ulysses DeGagne and Bernice Gloria DeGagne;

**Now Therefore** The Corporation of the City of Kenora enacts as follows:

1. **That** part of the Lane between Lots 5, 6 & 7, Block 11, Plan 18, Town of Keewatin, now City of Kenora, District of Kenora, designated as Part 1, 23R12015 be and the same is hereby assumed, stopped up and closed.
2. **That** The Corporation of the City of Kenora hereby **declares** that the land described as follows:  
part of the lane between Lots 5, 6 & 7, Block 11, Plan 18, Town of Keewatin, now City of Kenora, District of Kenora, designated as Part 1, 23R12015 **as surplus lands**.
3. **That** The Corporation of the City of Kenora shall transfer to Emile Ulysses DeGagne and Bernice Gloria DeGagne part of the Lane between Lots 5, 6 & 7, Block 11, Plan 18, Town of Keewatin, now City of Kenora, District of Kenora, designated as Part 1, 23R12015, provided that a registration pursuant to Section 118 of the Land Titles Act is registered to provide that this property shall be a lot addition to the property owned by the Transferees, and in exchange the DeGagne's will pay the City for the Harvey and Zdep properties.
4. **That** the Purchasers have undertaken and agreed to pay all related costs including appraisal fees, advertising fees, legal fees, survey fees and any other disbursements related to the transfer of the above noted property.
5. **That** the Mayor and the Clerk be and they are hereby empowered to execute documents in connection with the assuming, stopping up, closing and selling of the hereinbefore mentioned lands.

**6. That** this By-Law shall come into force and be in effect from and after the final passing thereof.
