## By-Law Number 114 - 2011

### A By-Law to Amend Schedule "B" To By-Law Number 147-2007 Being a By-Law to establish a General Tariff of Fees and Charges for the City of Kenora

**Whereas** Council adopted By-law Number 147-2007 on the 10<sup>th</sup> day of December, 2007; and

**Whereas** it is deemed necessary and expedient to amend Schedule "B" (Community Services) to By-law Number 147-2007 to meet changing requirements and to amend various rates into the Tariff; and

**Whereas** public notice has been given in accordance with Notice By-law Number 144-2007 that changes will be made to the advertising rates for the recreation facilities, as well as for personal training fees and the rate for private swimming lessons;

**Now Therefore Be It Resolved That** the Council of the Corporation of the City of Kenora hereby enacts as follows:-
