By-Law Number 81-2012

A By-law to amend By-Law Number 80-2006 being a By-law to authorize the Issuance of certain licenses and to provide Regulations therefore, in the City of Kenora

Whereas Council of the City of Kenora adopted By-law Number 80-2006 on the 12th day of June, 2006 being a by-law to authorize the issuance of certain licenses and to provide regulations therefore; and

Whereas Council amended By-law 80-2006 by adopting By-law Number 93-2008 on the 16th day of June, 2008; and

Whereas it is deemed necessary and expedient to further amend By-law Number 80-2006 with respect to mobile food vending on municipal property in order to meet changing requirements;

Now Therefore be it resolved the Council of the Corporation of the City of Kenora hereby enacts as follows:-

1. That the Definitions Section 2 of By-law Number 80-2006 be and is hereby amended by deleting the term "Refreshment Vehicle" and its meaning and replacing it with the term "Refreshment Booth" to mean as follows:

"any vehicle, cart, tent, trailer, truck or other mobile facility used for the sale of goods, wares, or for the provision of any services, including but not limited to motorized, non-motorized or physically propelled mobile food vending equipment."

2. That the Vending Regulations Section 15 of By-law Number 80-2006 be and is hereby amended by replacing the reference of "Refreshment Vehicle" to "Refreshment Booth" in that section.
3. That the Vending Regulations Section 15 of By-law Number 80-2006 be and is hereby amended to include an additional exception to the existing provisions as follows:

Add Exception:

Notwithstanding the Vending Regulations contained in Section 15 of By-law Number 80-2006 that states a "Refreshment Booth" is not permitted on municipal property, save and except during a fair, exhibition, festival, celebration or other public gathering or special occasion authorized by the City of Kenora and prior approval from the approved event organizer(s), permission is hereby granted by authority of this by-law to the Lake of the Woods Development Commission's "Mobile Food Program" (as approved through a public RFP process) for the establishment of five (5) mobile food vendors to operate on municipal property, subject to the terms and conditions established for this purpose through the RFP, at the following locations between July 1 and September 3:

- Three (3) Refreshment Booths at the tent area of the Harbourfront;
- Two (2) Refreshment Booths at the Lake of the Woods Discovery Centre (north end of the lower parking lot).

4. That the Vending Regulations Section 15 of By-law Number 80-2006 be and is hereby amended to include the following provision to the exceptions of this section as follows:

Public Liability Insurance:

- (i) The operator of any 'Refreshment Booth' shall comply with and provide evidence of a current policy of public liability insurance for a minimum of Five Million Dollars (\$5,000,000.00) coverage.
5. That By-law Number 93-2008 be and is hereby repealed.
