

**The Corporation of the City of Kenora**

**By-Law Number 38 - 2015**

**A By-Law to Authorize the Entering Into of an Agreement to Authorize a Transfer of Land from Donald Cameron, Christopher Conway, Maureen Conway, Sandra Conway, Brian Ingo, Mary Lou Ingo and Robert Stout to the Corporation of the City of Kenora part of Mining Loc K8, being Part 2, Plan 23R12358, City of Kenora, District of Kenora**

Whereas the Corporation of the City of Kenora deems it necessary and expedient to enter into an Agreement for the acquisition of certain lands; and

Whereas the Corporation of the City of Kenora has reached an Agreement with Donald Cameron, Christopher Conway, Maureen Conway, Sandra Conway, Brian Ingo, Mary Lou Ingo and Robert Stout to acquire certain lands for municipal purposes; and

Whereas Donald Bruce Cameron, Christopher James Conway, Maureen Michele Conway, Sandra Joan Conway, Brian Ardagh Ingo, Mary Lou Ingo and Robert Allan Stout have agreed to transfer to The Corporation of the City of Kenora the property described as part of Mining Loc K8, being Part 2, Plan 23R12358 for \$1.00;

Now Therefore The Corporation of the City of Kenora enacts as follows:

1. That the Corporation of the City of Kenora hereby enters into an agreement with Donald Bruce Cameron, Christopher James Conway, Maureen Michele Conway, Sandra Joan Conway, Brian Ardagh Ingo, Mary Lou Ingo and Robert Allan Stout to acquire the land described as part of Mining Loc K8, City of Kenora, District of Kenora designated as Part 2, Plan 23R12358, for the sum of \$1.00, which Agreement is attached hereto and forms part of the By-law.
2. That the Corporation of the City of Kenora shall acquire from Donald Bruce Cameron, Christopher James Conway, Maureen Michele Conway, Sandra Joan Conway, Brian Ardagh Ingo, Mary Lou Ingo and Robert Allan Stout Part 2, Plan 23R12358 for the sum of \$1.00.
3. That the Mayor and the Clerk be and they are hereby empowered to execute any and all documents related to the transfer of the above-noted property.
4. That this By-law shall come into force and be in effect from and after the final passing thereof.
