By-Law Number 60 - 2016

A By-Law to Assume certain roads and lanes on Plan M63 being PINs 42168-0185, 42168-0471 portions of First Avenue South and former spur tracks being PINs 42166-0888, 42168-0887, 42166-0079, 42165-0414 and 42165-0413 and assume them as public highways for municipal purposes, City of Kenora, District of Kenora.

A By-Law to Assume Second Street and Third Street on Plan M133, Dufresne Island, being PINs 42180-2333 and 42180-2334. A laneway being PIN 42180-2428 and Wide Street being PIN 42180-2331, City of Kenora, District of Kenora

Whereas the Council of the Corporation of the City of Kenora, deems it necessary and expedient to assume certain roads and lanes on Plan M63 being PINs 42168-0185, 42168-0471 being portions of First Avenue South and former spur tracks being PINs 42166-0888, 42166-0887, 42166-0079, 42165-0414 and 42165-0413 and assume them as public highways for municipal purposes, City of Kenora, District of Kenora; and

Whereas the Council of the Corporation of the City of Kenora, deems it necessary and expedient to assume Second Street and Third Street on Plan M133, Dufresne Island, being PINs 42180-2333 and 42180-2334. A laneway being PIN 42180-2428 and Wide Street being PIN 42180-2331, City of Kenora, District of Kenora;

Now therefore Be it Resolved that Council of the City of Kenora Enacts As follows:-

1. That certain roads and lanes on Plan M63 being PINs 42168-0185, 42168-0471 being portions of First Avenue South and former spur tracks being PINs 42166-0888, 42166-0887, 42166-0079, 42165-0414 and 42165-0413 more particularly described in Schedule A and assume them as public highways for municipal purposes, City of Kenora, in the District of Kenora be and the same is hereby assumed.
2. That Second Street and Third Street on Plan M133 being PINs 42180-2333 and 42180-2334, A laneway being PIN 42180-2428 and Wide Street being PIN 42180-2331 more particularly described in Schedule B, City of Kenora, in the District of Kenora be and the same is hereby assumed and stopped up.
3. That the Mayor and the Clerk be and they are hereby empowered to execute documents in connection with the assuming the hereinbefore mentioned lands
4. That this By-Law shall come into force and be in effect from and after the final passing thereof.

5. That the Corporation of the City of Kenora By-Law 3-2016, By-Law 11-2016 and 12-2016 are hereby repealed.
