## By-Law Number 118 – 2016

## A By-Law to Adopt Amended Estimates for Operating and Capital Reserves to be incorporated into the Sums Required for Municipal Purposes during the Year 2016

**Whereas** Council of the City of Kenora adopted the 2016 Municipal Five Year Capital Plan by passing By-law Number 26-2016 on April 19, 2016 and further the 2016 Municipal Operating Budget by passing By-law Number 40-2016 on May 17, 2016; and

**Whereas** the City of Kenora Procurement Policy # CS 1-1 the Corporate Services Manager has the authority to reallocate funds from 'within the same department or function that has either been completed under budget or has been deemed of a lesser priority by that (being the questioning) Manager'; and

**Whereas** As part of this authority, the Corporate Services Manager shall be required to report any such transfers to Council on an annual basis for the purpose of passing a budget amendment By-law to formally amend the budget to reflect the reallocation of funds'; and

**Whereas** at the Committee of the Whole meeting held October 4, 2016, a report was presented to Council outlining the budget reallocations approved by the Manager of Corporate Services & Strategic Initiatives under the Procurement Policy guidelines for the year 2016; and

**Whereas** public notice of this amendment has been given in accordance with Notice Bylaw Number 144-2007;

**Now Therefore** the Council of the Corporation of the City of Kenora Hereby enacts as follows:
