## By Law Number 82 - 2017

### A By-law to amend By-Law Number 180-2015 being a By-law to Regulate Traffic and Parking in the City of Kenora

Whereas the Council of the City of Kenora adopted By-law Number 180-2015 on the 15th day of December, 2015; and

Whereas it is deemed necessary to amend the By-law to accommodate changing requirements;

Now therefore be it resolved that the Council of the City of Kenora enacts as follows:-
