## By-Law Number 2 - 2018

## A By-Law to Provide for Annual Remuneration to the Mayor and Members of Council of the Corporation of the City of Kenora

Whereas Section 283(1) of The Municipal Act, S.O. 2001, c. 25, as amended, provides for payment of remuneration to the Head and Members of Council; and

Whereas Section 283 (5) of The Municipal Act 2001, S.O. 2001, c.25, which came into force and effect on 1 January 2003 states that if a resolution of a municipality under subsection 255 (2) of the old Act is not revoked before January 1, 2003, the resolution shall be deemed to be a by-law of the municipality and one-third of the remuneration paid to the elected members of the council and its local boards is deemed as expenses incident to the discharge of their duties as members of the council or local board; and

Whereas Section 283 (7) of the Municipal Act 2001, S.O. 2001, c.25 requires that a council shall review a by-law under subsection (5) at a public meeting at least once during the fouryear period corresponding to the term of office of its members after a regular election; and

Whereas the Council of the City of Kenora has reconfirmed the declaration that one-third of the remuneration paid to elected Members of Council of the City of Kenora shall continue as expenses incident to the discharge of their duties as Members of Council during each term office since the original by-law was passed in May 2005; and

Now Therefore the Council of the Corporation of the City of Kenora enacts as follows:~

- 1. That the economic adjustment that was approved for City non-union staff for 2018 was 1.5%, approved at the December 12, 2017 Council meeting;
- 2. As per City policy #CC-15-1 a corresponding adjustment of 1.5% is now hereby authorized to establish a like increase for Council remuneration;
- 3. That for the year 2018 the annual remuneration of the Head of Council shall be Thirty Three Thousand, Four Hundred and Twenty Dollars (\$33,420.00);
- 4. That for the year 2018 annual remuneration of Members of Council shall be Sixteen Thousand, Seven Hundred and Ten Dollars (\$16,710.00) per annum;
- 5. That for the year 2018 the per diem rate be paid to the Head of Council and Members of Council in the amount of \$184.00 and includes travel days. If four (4) hours or less in duration then 50% of this approved rate shall be paid;
- 6. That any other honorariums may be paid to the Head of Council or Members of Council for serving on other Boards, Committees or Commissions, in accordance with City Policy;
- 7. That all other associated expenses, i.e. travel, meal allowance, out of City mileage, etc. shall be paid in accordance with City Policy;

- 8. That one third (1/3) of such amounts shall be deemed to be for expenses incident to the discharge of the duties as Head and/or a Member of the Council;
- 9. That this By-law shall take effect on third and final reading, thereby repealing Bylaw Number 46-2017.
