By Law Number 106 - 2019

A By-law to amend the Rules and Regulations at the Lake of the Woods Cemetery

Whereas the Lake of the Woods Cemetery in the City of Kenora is owned by the Corporation of the City of Kenora; and

Whereas the Cemeteries Act, (Revised,) R.S.O. 1990, Chapter C-4, provides that an owner of a cemetery may make by-laws for regulating the operation of the cemetery;

Whereas on January 17, 2017 bylaw number 6-2017 was adopted by Council to govern the rules and regulations at the Lake of the Woods Cemetery; and

Whereas it is deemed necessary to now make amendments to bylaw number 6-2017;

Now Therefore the Council of the Corporation of the City of Kenora hereby enacts as follows:

1. That under Section 4: Burial of Cremated Remains, **4.09 is added** to read:

"All full burials will require a minimum vault structure of fibre glass. Plywood vaults are not permitted".

 That Section 7: Lot Decorations, Lot Decoration Rules (May 31st – October 1st) be amended to reflect the date of:

(May 1st – October 1st)

3. That Section 7: Lot Decorations, Lot Decoration Rules (October 2nd to May 30th) be amended to reflect the date of:

(October 2nd to May 1st)

4. That Section 7.03 Artificial Wreaths that currently reads:

Artificial and/or silk flower arrangements/wreaths, attached to a stand or monument, may be placed on gravesites and remain there from the Friday before Thanksgiving to May 1st of the following year. Dates will be posted in local newspapers with regard to lot decoration rules. Any item that does not comply with the lot decoration rules that remain after May 1st will be removed by Cemetery Staff and placed into a recovery area that is visible to the public. Items not picked up by July 1st will be discarded.

Be replaced with:

Artificial and/or silk flower arrangements/wreaths, attached to a stand or monument, may be placed on gravesites and remain there from the Friday before Thanksgiving to <u>April 1st</u> of the following year. Dates will be posted in local newspapers with regard to lot decoration rules. Any item that does not comply with the lot decoration rules that remain after <u>April 1st</u> will be removed by Cemetery Staff and placed into a recovery area that is visible to the public. Items not picked up by <u>June 1st</u> will be discarded.

5. That this By-law shall take effect and come into force upon third and final reading and a copy be directed to the Ministry of Consumer Services for the Province of Ontario.
