New Business

➤ Safety Issue

Member Dave Canfield raised the issue of the Black Sturgeon bridge construction area on the Reddit Road. This bridge that crosses the Black Sturgeon isn't finished construction and they intend to leave it closed to one lane for the winter. The construction company has no intention of getting rid of the jersey barriers and the lights for the winter. The side that is open is quite narrow and there is a very steep slope leading to the bridge. They need to open that bridge for the winter or someone is going to get hurt there. Detachment Commander Duggan indicated he would look into and see if there is anything the OPP can do.

Detachment Commander's Report – Resolution #4

Moved by A. Poirier, Seconded by W. Van Belleghem & Carried: -

That the Kenora Police Services Board hereby accepts the Kenora OPP September 2021 monthly report as presented.

Discussion: Detachment Commander Duggan reviewed the September 2021 stats. The new ICON system that provides the data is not providing monthly stats so some information isn't available. Number of calls for service is 1,305 which doesn't include criminal record checks or e-tickets.

They are going to run six temporary assignments over the winter. Clearance rates for September is 58.3%. D/C Duggan intends on doing a year-end report which will demonstrate a higher clearance rate. Foot patrol hours are 122. The marine unit hours are not accurate but they are still out on the lake as break and enters are higher at this time of the year. Behavioural mental health support hours are 16 out of 40 were diverted from the hospital. The wait time is still over 2 hours. Do not have mobile crisis team stats but will have the stats for next meeting.

We have a new community services officer, Mike Barclay. He will be working with Jason Canfield and the social media information. He will be in schools and also downtown with foot patrol. URT members are on own separate platoon. The number one focus are downtown safety and have other duties. Expect officers to be downtown and have more foot patrol hours. Started on 10th of October. The state of downtown similar to other winters we see a decrease in the presence of people on the streets. The rural officer is in full swing and has been increasingly present on the Redditt Highway. They need to catch up on some much needed training so many officers are away to partake in various training.

Councillor Poirier received four calls from business owners in the downtown who have seen a difference in presence in the downtown. Officers are working hard to ensure a continual presence in the downtown and raise the comfort level with the public and safety.

Mayor Reynard questioned the calls for service for bears and questioned if it is logged as a call for service. D/C Duggan confirmed that it is considered a call for service for the City. The OPP have to attend with the MNR for bear calls. They are working 20 hour days trying

to relocate bears. D/C will provide the data to the Board on how many calls for service they received in 2021.
