## **D.** Deputations/Presentations

### Community Safety and Well Being

Felix Munger from the Crime Prevention Network Presentation will soon be known as the Canadian Centre for safer communities. The vision for the organization is for Canadian communities where people are safe and feel safe. The mission is to inspire local action and foster community safety and well-being through national leadership, collaboration, capacity building and knowledge exchange.

They provide a lot of training, research and publications regarding rural crime prevention, social challenges/social inclusion, adverse childhood experiences, restorative justice.

Key safety issues in Canada include substance use and drug poisoning, mental illness, homelessness/houselessness, domestic and interpersonal violence, gun and gang violence and rising crime index.

60-80% of calls to police are not crime related. Police often do not have jurisdiction and are often not trained in the areas not related to the calls such as mental health crisis, homelessness and addiction. The revolving door with justice system brings attention to the fact that we cannot arrest our way out of these problems. We need to get to the sources and address the root causes. We need to think about a new approach to community safety. Kenora was one of the pilot sites for a community safety and well-being plan.

There are root causes and risk factors of crime and victimization are found in social, economic, cultural, and societal systems that can lead to inequities and disadvantages.

Communities are now mandated to have Community Safety and Well Being plans. Both federal and provincial governments are now using language that is often reflected in these plans. Rural communities are facing unique challenges but also implementing these plans.

Changes take time, and some communities are hiring staff to ensure that the contents of the plan is moving forward. These roles the staff lead brings the community partners together to advance the plan. Thunder Bay has a lead as a facilitator and the idea is to have the City as the convener. They have an ongoing steering committee that works together with the staff lead to advance the plan.

There is education required to educate that the sense of safety and the reality of safety may be different.

February 8, 2023 Committee of the Whole Meeting Minutes Council thanked Mr. Munger for his presentation and a copy was left with the Clerk.

#### 2022 Bridge Inventory and Audit Presentation - Stantec

Eric Tranquada from Stantec provided an overview of the 2022 bridge inventory and audit.

Bridge condition index is a weighted scoring for each bridge and rates the structure from zero to 100 with 100 being brand new. The BCI is used as an indicator to determine a bridge's overall condition to help with resource and bridge management.

There is difficulty attracting qualified contractors to complete non-capital maintenance work. It is recommended grouping maintenance together into larger work packages for tendering and bidding. Costs have been found to increase following the pandemic while also proving to be volatile with short term validity for estimates.

Current investing recommendations total cost is \$410,000. The BCI comparison over the years from 2016, 2020 and 2022 which indicate consistent change with incremental decreases in BCI. There is an upward trend that is demonstrating that repair and rehabilitation is successful for asset value and BCI.

### **1.2** Ontario Good Roads Association (OGRA) Delegation Requests

The annual OGRA Conference will be held in Toronto this year April 16-19, 2023. One important part of these municipal conferences is the opportunity to meet with various Ministers and their staff to discuss important issues to the municipality. Delegation meetings with Cabinet Ministers are a key feature of the OGRA Conference and are a unique opportunity for council to engage with Ministers, Parliamentary Assistants and senior Ontario Government officials on local matters that impact our municipality. Registered OGRA conference delegates can now request an in-person meeting with a minister or parliamentary assistant at the OGRA conference. The deadline to submit our request is March 17, 2023. We have two members of Council registered to attend, Councillor Manson and Councillor Chaze.

Council supported submitting a request in regards to our ongoing challenges of the high costs of our infrastructure, specifically bridges. Every opportunity we get we need to emphasize the challenges we have with our bridges. Heather will submit one request for the OGRA conference by March 17, 2023.

## **1.3** Crime Prevention & Community Well-Being Advisory Committee Terms of Reference (Deferred from January 18<sup>th</sup> Council Meeting)

#### **Recommendation:**

That Council hereby amends the Terms of Reference for the Kenora Crime Prevention & Community Well-Being Advisory Committee; and further

That three readings be given to a bylaw to adopt a new Terms of Reference

**Discussion:** Council would like to add to the voting members: Judicial system, youth probation, member of Council, member from the business community. These will be added to the new bylaw for adoption at next week's meeting.

Discussion continued around the timing of the recruitment of members. Administration will begin to recruit and will reach out directly to these identified organizations to identify a person who would be a strong contributor to the work the committee will be doing.

## 1.4 2023 Five Year Capital Budget Approval

### **Recommendation:**

That Council hereby approves the 2023 Five-Year Municipal Capital Budget, as amended; and further

That Council hereby directs staff to actively proceed with the projects included in that budget in accordance with the provisions of the City procurement bylaw; and further

That in accordance with Notice Bylaw 160-2022, public notice is hereby given that Council intends to adopt its 2023 Five-Year Municipal Capital Budget at its February 15, 2023 Council meeting; and further

That Council hereby gives three readings to a bylaw for this purpose.

**Discussion:** A number of budget meetings have occurred. As a result of those discussions, we will defer downtown revitalization Matheson & First Street South design and tender to 2026 and 2027 respectively; additional Ontario Community Infrastructure Fund of \$1,224,862 be allocated to roads infrastructure replacing net tax levy funding; replace office renovation and expansion net tax levy funding of \$242,000 with reserve funding.

There is no net tax levy that is included in the capital budget. Staff worked hard to find funding alternatives to not have the capital budget impact tax payers. Council thanked the province for their support in various funding. It is Council's role to maintain the financial integrity of the City and deliver on the strategic priorities of the City. We need to continue to consider the long term investment in our infrastructure and face the future needs and costs of that infrastructure.
