# **D. Deputations/Presentations**

### **BEHR Integrated Solutions - Master Fire Plan**

Jeff Carlisle & Isaac Comandante, Senior Fire and Emergency Operations and Management Specialists presented the City of Kenora Fire and Emergency Services Master Fire Plan. The Master Fire Plan can be referred to as 'road map' to the future and used as a guiding document for current and future fire service leaders and municipal decision makers. Goals of the plan include but are not limited to enhance firefighter safety, enhance cost control and containment, identify the right sized service to meet the current and future needs of the community and increase efficiency and effectiveness.

#### **Prudent Investors - Investment Presentation**

Keith Taylor, CFA, Chief Investment Officer and Jennifer Hess, Manager, Investment Services Municipal Finance Officer's Association (MFOA), presented to Council. ONE Investment is a not-for-profit organization dedicated to serving the investment needs of the Ontario municipal sector managing over \$2.95 billion in portfolio holdings as of December 2022.

Kevan Sumner, City Planner presented an overview of the Planning framework in Ontario, the Official Plan and Zoning By-law, Planning Tools, and Council and the Planning Advisory Committee.

# **E. Reports:**

# 1. Corporate Services / Finance / Human Resources

# 1.1. Council Committee Work Update Information Only

**Councillor Manson** – Handi-Transt meetings fall on the same date as Committee of the Whole, Councillor Manson has requested the meetings date/time be amended. Kenora Public Library Board - nothing to report.

**Councillor Koch** – The MUSE is far into recruitment for the Director position with a third-party recruiter. The MUSE will have policy updates coming to Council. The Douglas Family Art Centre has a textile exhibit called In the Middle of the World until June 17<sup>th</sup>. The MUSE currently has the Something to Talk About exhibit on the 1973 Kenora Bank Robbery which closes on June 10<sup>th</sup>. Councillor Koch is participating in Drowning Prevention Research Centre sessions to focus on the development of a community drowning prevention and boating injuries study.

**Councillor Bernie** – The BIZ will be meeting next week. The group is looking at formalizing their meeting dates for the 3<sup>rd</sup> Thursday of every month at 5:00 p.m. In conjunction with Tourism Kenora, the BIZ is looking at hosting 3 downtown markets, including one in the evening with live music. Hennipen Lane beautification is a project the BIZ is exploring. Simple things to rejuvenate the area and direct traffic there would be a big win. The Northwestern Health Unit Board (NWHU) – Several members of Council and NWHU board members attended NOMA. Locally, Dr. Kitt Young Hoon is a member of the expert panel advisory committee on cannabis, alcohol, tobacco and opioids. The region is represented and there will be a report in the fall of 2023. Crime Prevention and Community Wellbeing Advisory Committee – The City is looking forward to getting the committee established. There have been a number of applications received for the committee. The City is still in the process of hiring the Community Safety Coordinator.

**Councillor Chaze** – No updates at this time.

**Councillor Van Belleghem** – As a member of the Police Services Board Councillor Van Belleghem will be attending the Ontario Association of Police Services Board Conference in Niagara at the end of May. Accessibility Advisory Committee (AAC) - National AccessAbility Awareness Week is May 28<sup>th</sup> to June 3<sup>rd</sup>. At the May AAC meeting Shaun Clifford, Facilities Manager presented new park upgrades and developments. Accessibility and inclusion features are integrated into all new park upgrades and developments. Consultation took place with FireFly to create an autism calming centre, also known as a miracle museum, at Norman Park. The majority of new installations will include a rubber matting ground cover. The need for seating was also identified to encourage inter-generational play.

**Councillor Moncrief** – Earlier this month was the flag raising for the Kenora Festival of the Arts. There were two Kenora District Services Board (KDSB) finance and audit meetings. The auditors presented and the reports will be made public after the next board meeting. Councillor Moncrief, Councillor Koch and Councillor Van Belleghem attended the Association of Municipalities of Ontario (AMO) Foundations in Planning course. Councillor Moncrief expressed the course was very helpful and would like to see this part of Council orientation. All Nations Health Partners (ANHP) – Councillor Chaze was unable to attend the ANHP meeting so Councillor Moncrief attended in his absence and found it very informative. There is a lot of conversation and a lot going on with the group. They are very aware of the City being a partner and continuing conversation. Although the City does not provide direct health services through the municipality the City does intersect with health providers. KDSB Board meeting – As a result of a discussion of a particular property that was under consideration for acquisition by the KDSB, it was reiterated that municipalities need to be included in conversations about the location of KDSB properties because the density of social programs and housing could substantially impact a neighbourhood. Kenora's core is saturated and consultation is very important. Kenora Airport

Authority – The airport is doing well despite slowed service levels during COVID and last year's paving on the airport runway. They are geared up and ready for a busy summer. The board is looking forward to building a relationship with City as further opportunities come forward. Members of Council attended the Weyerhaeuser mill opening. It is an impressive plant. Historically as a municipality there is a lot of time and money spent attracting new business, hopefully the City can foster relationships with existing business and encourage healthy growth and development in our area. Culture and events in the community included A Sharing of Our Stories, Common Ground Story Telling, King Fisher Days at TryLight Theater and G Clef and Music Men Choir hosted a performance at Knox United Church. The Home and Leisure Show was held April 28<sup>th</sup>-30th, members of Council were in attendance and had lots of conversations, people are keen. Council heard you and will work your comments into conversations.

Mayor Poirier - The Kenora Health Care Centre Board of Directors meeting was attended by Councillor Koch and Mayor Poirier. The budget was passed, there was discussion on the space and what is available. Challenges with recruiting doctors were discussed, numbers are down which has a direct correlation with the budget and who pays what. Financially the Board is fine but vacancies need to be filled. Members of the board are working with groups that are tenants of the building, to come up with ideas. There was a discussion at the meeting regarding the membership of the committee. Currently the board has three Councillors, three members of the Kenora Medical Association, one member at large and one staff. The Kenora Medical Association is having difficulty filling board positions. There will have to be changes through by-law because it is non-profit corporation. The City Clerk has been reaching out to other organizations with a similar makeup. Council can go outside this body of Council, members can be whoever Council deems appropriate to represent the City on the committee. The City is connected to the organization because the City secures an extremely large mortgage on the building. If mortgage payments aren't made, the City of Kenora is responsible for it. The mortgage is carried on the books as secured liability. Overall, it was a good board meeting and there will be more to come. Mayor Poirier was invited to the District Chamber of Commerce meeting. It was the swearing in for president, vice-president, etc., however some were unable to attend. Mayor Poirier has been asked to come back and swear in the members in the near future. Mayor Poirier provided a lot of information to the board on what Council and staff are doing in the community. There was discussion about the downtown and lobbying of governments, as well as a Q&A period. It is important that the City has a connection with the Chamber of Commerce. Mayor Poirier invited them to attend a Council meeting and provide information on what is going on. Kenora District Municipal Association (KDMA) had their first meeting. Prior to this there has been no formal meeting this term. The mandate and how to move forward with the organization were discussed. The group is looking at an all Mayors Council but not all municipalities are in favor. Mayor Poirier is the third Kenora Mayor on the Northwestern Ontario Municipal Association (NOMA) board as a director from the Kenora district. The board is a very good group of people including Councillors, Mayors, CAOs, and other staff members of municipalities. Mayor Poirier attended his first meeting before the NOMA conference and the board will meet every two or three months. If you want to be heard you need to be seen. Kenora needs to be at the table, we are the second largest municipality in NOMA. At the Home and Leisure Show Mayor Poirier was approached and guestioned if City Hall is moving to another location. To reassure people, Council and staff have not been involved in any discussion to move City Hall to the Operations Building.

### 1.2. 2023 Tax Rates & Ratios

### **Recommendation:**

Therefore Be It Resolved That the City of Kenora, aligned with the Federation of Northern Ontario Municipalities (FONOM) requests the Federal Government make these Legislative changes by;

- 1. Creating a Designation of a chronic persistent offender.
- 2. Allowing community impact statements at bail and at bail hearings.
- 3. Creating reverse onus in bail for all firearms offences.
- 4. All bail-related gun charges go to the superior court for bail release; and

That a copy of this resolution be sent to the Prime Minister, Federal Justice Minister, Premier of Ontario, The Attorney General, the Solicitor General, Minister of Infrastructure, Minister of Municipal Affairs, the Honourable Greg Rickford, Kenora-Rainy River MPP, Eric Melillo, Kenora MP, Leaders of the Opposition, the Association of Municipalities of Ontario, and the Federation of Northern Ontario Municipalities.

#### **Discussion:**

It was asked if there has been any community consultation specifically in our area being that Kenora is a justice hub. There has not been consultation that City staff are aware of, this resolution was generated at the FONOM conference held last week. Council expressed concerns with the wording on guns related charges and requested this language be changed to weapons related charges.
