2023 Organization Budget Requests

Kenora Public Library

Marj Poirier Vice-Chair of Kenora Public Library Board presented their 2023 operating budget proposal which includes some increases in the budget which includes a 3.2% increase over 2022's budget.

Triple PLAY

Barry Reynard, Program Coordinator and Darcia Curtis, Board Chair presented Council with their 2023 budget request.

There has been devastating impacts of pandemic (2020-2022) and there are significant barriers to sports and cultural activities. Participation in organized sports and activities is declining and parents are finding an increase in mental health concerns for children and youth. The 2023 request from the City of Kenora is \$12,000.

All Nations Health Partners - Physician Recruitment Committee

Ray Racette, Chair, All Nations Health Partners (ANHP) Recruitment Committee. This is a very active committee that the City of Kenora is represented on. Its key purpose is to provide oversight and support for our professional recruiter, Jennifer Savage, who joined the ANHP team three months ago. The professional recruiter role is critically important for our region and leads the effort to recruit professional staff, such as family physicians, emergency room physicians, specialists, nurse practitioners, and locum physicians to our Region. The professional recruiter is also responsible for supporting the medical students and residents, welcoming them, and focusing on enhancing their learning experience in the hopes that they will return to work in Kenora and its surrounding communities.

The City of Kenora has provided \$25,000 per annum to support the Professional Recruiter position, which the ANHP has greatly appreciated. For 2023, we are requesting the City of Kenora to increase their contribution to \$40,000 per annum to support increased advertising and marketing initiatives, increased travel for the professional recruiter to

attend recruitment fairs, and increased travel expenses to support site visits for potential recruits.

Community Safety & Well Being Coordinator Position
