#### **Deputations**

#### **Ne-Chee Friendship Centre – Kenora Legion Purchase**

Patti Fairfield was present to advise Council that they have purchased the Kenora Legion building. They are remaining in the current location on Second Street South to continue their programming. The biggest purpose for purchasing the building is for the auditorium. This was a prime opportunity for them to expand and have the opportunity to expand and have space for larger events. They have agreed to lease the canteen space to the Kenora Legion for up to two years and will give them time to find another location.

Council thanked Patti for her presentation and the information shared with the public.

**FoodCycle Science – FoodCycler\_Pilot Program Survey Results Presentation**Jessica Taylor form FoodCycle Science provided the results from the 2023 FoodCycle pilot program. There are 97 municipal partners in the program. With support from Impact Canada's Food Waste Reduction Challenge a second pilot program was run in the City of Kenora that included 250 participating households.

We now have 500 FoodCyclers in the City of Kenora (6.5 total private dwellings).58.5 MT of food waste diverted from landfill/year from 250 FoodCyclers in pilot program. 83.18% of residents reported a reduction in their monthly garbage production as a result of diverting their food waste. 99.5% of participants will continue using the FoodCycler. 500 FoodCyclers in Kenora (~6.5% total private dwellings) diverting. ~118MT of food waste from landfill/year. Next Steps are expanded program to reach more households Comprehensive municipal program designed for you by Food Cycle Science.

# **Coker Road Geotechnical Report Options**

That given the stabilization of Rice Bay water levels during June 2023, Council directs administration to proceed immediately with the reopening of Coker Road, subject to both:

 the required road maintenance, culvert repair, and drainage ditching, acknowledging that the costs for the City of Kenora's Engineering Department support and the required contractor costs and contract administration costs are not included in Stantec's Option 3 opinion of probable cost; and further

That administration presents a budget amendment, to be developed through total scope pricing of Option 3, to Council in Council's September 2023 Committee of the Whole meeting; and further

That Council directs administration to proceed with Option 2B - Realignment of Coker Road with a 50km/h design speed and that a placeholder for this work be incorporated into the 2024 budget development process.

# Deeming certain lands not to be a registered plan of subdivision

Pursuant to the provisions of Section 50(4) of the Planning Act, RSO 1990, c. P.13, as amended, the Council of a local municipality may by bylaw designate any plan of subdivision, or part thereof, that has been registered for eight years or more, which shall be deemed not to be a registered plan of subdivision for the purposes of Subsection 50(4) of the said Act; and further

That Lots 11 and 12, Block 72 on Registered Plan of Subdivision Plan 18 in the City of Kenora are within a plan of subdivision registered for more than eight years; and further

That Council gives three readings to a bylaw to deem the above-mentioned lands not to be a registered plan of subdivision for the purposes of Subsection 50(3) of the Planning Act.

# Declare lands Surplus to the needs of the Municipality and sell lands-117 Main St S
