Application for an Exemption to the Sign Bylaw-Moncrief Construction 2b. Moved by G. Chaze, Seconded by K. Van Belleghem & Carried:-

That Council hereby approves an exemption under the Sign License Bylaw number 115-2010 to allow for a $11.8 \text{m} \times 1.5 \text{m}$ illuminated sign within the Harbourtown Centre Zone that will display the naming rights of Moncrief Construction for the Kenora Recreation Centre for a 15 year period in accordance with the sponsorship agreement.

Discussion: Naming rights for the Kenora Recreation Centre were sold to Moncrief Construction LTD in February 2023 for a fifteen year sponsorship. As per the agreement, Moncrief is in charge of design, installation and maintenance of the building signage. Upon review of the bylaw, the facility falls within the Harbourtown Centre zone which prohibits signs taller than 1.5 meters and a maximum area of .20 square meters. Additionally, signage cannot be illuminated within the Harbourtown Centre. Alternative options have been presented by administration but the company has a strong preference to the proposed signage.

K. Van Belleghem - Exploration of Permanent 24 Hour Centre

I, Councillor Kelsie Van Belleghem, provided Council a Notice of Motion at the February 18, 2023 regular meeting of Council of my intent to bring forward the following motion at tonight's March 22, 2023 meeting:

Whereas the City of Kenora experiences extreme temperatures in the winter and summer seasons; and

Whereas municipalities across Canada are facing a homelessness crisis that is leading to profound and devastating impacts on our communities; and

Whereas the City of Kenora acknowledges that there are complex issues which can be presented through the challenges of homelessness and a lack of transitional and affordable housing, which are most significantly felt at the local level on a daily basis; and therefore have a measurable and detrimental impact on the well-being of all citizens of the City of Kenora; and

Whereas the Ontario Human Rights Commission has identified a significant lack of cold weather services in municipalities across Ontario and has urged the provincial government, District Social Services Administration Boards (DSSABs) and Ontario municipalities to uphold the rights of people experiencing homelessness by ensuring the provision of around-the-clock indoor spaces for anyone seeking shelter are available; and

Whereas gaps in services and service hours have been identified by advocacy groups that have left people without access to washrooms and reprieve from the elements during certain times of the day;

Therefore be it Resolved that Council calls on housing and community partners to work in collaboration with one another, and liaise with the City's Community Safety and Well-Being Coordinator by committing to dialogue around feasibility of potential locations for a permanent 24-hour centre (Community Space) in an accessible area to align current existing services and supports being provided as well as identify solutions to gaps in service.
