Philip Cone – Zoning Bylaw/Official Plan

The Black Sturgeon Lake Property Owners Association represents over 150 properties on the Black Sturgeon Lake, and some functions of their association are to maintain the pristine nature of the water quality supported by policy within the City of Kenora Official Plan and guide surrounding built form on Black Sturgeon Lake though the provisions of the Kenora Zoning By-law. Discussion: Food Cycle Science expressed appreciation to the City of Kenora for their ongoing partnership and support in the Food Waste Reduction Challenge being run by Agriculture and Agri-Food Canada.

Food Cycle Science was selected as a finalist in the Challenge for our FoodCycler project to help small, rural, remote, Indigenous and Northern communities keep food waste out of landfills.

They are excited to be applying for the final stage of the challenge, with the potential to receive \$1.5 million in funding. Past funding from the challenge has been 100% reinvested into our Canadian municipal partnerships and pilot programs and they are committed to offering any future funding back to their municipal partners, including Kenora, to expand your FoodCycler program.

Food Cycle Science is requesting the City's support in their application by providing a letter of support. As an implementation partner with them since the early stages of the challenge, our support and partnership have been invaluable. They are seeking to have the City's endorsement as they move into the final stage of the competition.

Bail Reform Advocacy

6. Moved by G. Chaze, Seconded by R. Bernie & Carried:-

Whereas the cost of Policing and Emergency Services in Northern Communities is harming a community's ability to support local Social and Health issues; and

Whereas a small percentage of those affected by an Addiction in the communities of Northern Ontario are committing crimes; and

Whereas many of those committing crimes are not housed in the correctional system, therefore, remain in our communities, often those that do require treatment for their addiction issue receive none; and

Whereas some committing crimes become violent, but are released back into the community, due to the negative impacts Federal Bill C75; and

Whereas the Federation of Northern Ontario Municipalities (FONOM) believes that more must be done by the Federal Government on Bail Reform;

Therefore Be It Resolved That the City of Kenora, aligned with the Federation of Northern Ontario Municipalities (FONOM) requests the Federal Government make these Legislative changes by;

- 1. Creating a Designation of a chronic persistent offender.
- 2. Allowing community impact statements at bail and at bail hearings.
- 3. Creating reverse onus in bail for all weapons offences.
- 4. All bail-related weapons charges go to the superior court for bail release; and

That a copy of this resolution be sent to the Prime Minister, Federal Justice Minister, Premier of Ontario, The Attorney General, the Solicitor General, Minister of Infrastructure, Minister of Municipal Affairs, the Honourable Greg Rickford, Kenora-Rainy River MPP, Eric Melillo, Kenora MP, Leaders of the Opposition, the Association of Municipalities of Ontario, and the Federation of Northern Ontario Municipalities.

- 1. Councillor Koch announced the Glad you are Here event at the Discovery Centre this Friday. On May 20th is the Spring Fling market at the Pavillion. June 4th is the Pregnancy and Infant Walk. Mother's Day Run last weekend hosted by BBSS. Councillor Koch encouraged everyone to read the quarterly reports that were provided in the Committee of the Whole package this week. They really outline all the work being done by the City on projects and events. Playa Vida official regrand opening event today. Kenora held its first Moose Hide campaign event on May 11 which focuses on ending violence against women and children. These events are only a fragment of the positive things that are happening in our community.
- 2. Councillor Bernie recognized the OPP officer, Sgt Eric Mueller who was killed in the line of duty and called for a moment of silence. It is a sad situation. 10 officers have been killed in the line of duty in Canada, 6 that were in Ontario, since last September and this is becoming common now and change needs to be implemented to stop this happening in our country.

On June 1 City of Kenora Pride flag will be raised. Acknowledge how proud we are of our City and community for supporting diversity in our community.
