Call to Order

Mayor Poirier called the meeting to order at 5:00 p.m.

Land Acknowledgment Delivered by Councillor Koch

That circular economy retains and recovers as much value as possible from resources by reusing, repairing, refurbishing, remanufacturing or repurposing products and materials before they are recycled or thrown out; and further

That traditional 3Rs (reduce, reuse, recycle) considers the value of materials and products we purchase before they become waste; and further

That a goal of the Sustainability Advisory Committee is finding innovative ways to better the environment and reducing waste that ends up in landfills is a contributing factor to negative impacts to our environment; and further

That reintroducing a reuse area at the City of Kenora Transfer Station will help build a culture of waste reduction, reuse, sharing and repairing in Kenora, with a Community Reuse Program;

Therefore Be it Resolved that the Council for the City of Kenora directs administration to investigate a Community Reuse Program at the Kenora Transfer Station as soon as possible.

Discussion: Administration will look at the costs and any implications to introducing the program and a report will come back to Council.
