## Notice to All Owners of Property within a 60 metre radius of Property located at 717 Robertson Street, Kenora, ON SECTION 45 OF THE PLANNING ACT, RSO 1990

**TAKE NOTICE** that the City of Kenora has received an application for variance to Zoning Bylaw 101-2015 for a property located at 717 Robertson Street, identified in the Key Map below. The Kenora Planning Advisory Committee (PAC), who hears applications and considers recommendations to Council, will hold a virtual public meeting to consider the proposal at the following time and location:

**Purpose of Application**: To seek relief from the Zoning By-law 101-2015, Section 3.34.1(b) iv, which requires that accessory buildings may not be built closer to the street than the main building is to that street, as amended by Minor Variance Application File No. D13-22-06, which allowed for an accessory structure to be constructed closer to the street than the main building, at 14.0 m from the front lot line.

**Effect of Approval:** Would enable the applicant to locate an accessory garage closer to the street than the dwelling, at 4.0 m from the front property line.

**VIRTUAL PUBLIC MEETING:** All Committee meetings are being held virtually. There are several ways in which the general public can provide input on the proposed application for minor variance, as follows:

## **NOTES REGARDING YOUR RIGHTS**

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality before the Minor Variance Application is approved or refused;

- i. the person or public body is not entitled to appeal the decision of the City of Kenora Planning Advisory Committee to the Local Planning Appeal Tribunal.
- ii. the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.
