➤ Strategic Plan Next Steps

There has been more communication happening now through social media. The OPP are posting more lifestyle, good news stories, and infractions. They will be focusing on recruitment specific to Kenora. They do have a number of people trained in media, one per shift but it is on the NW Region Facebook page. Lifestyle, criminal activity, and it's about 3 posts per week for each detachment.

We need to focus on the strategic plan area as well. Jeff will need to speak with his team about narrative and what information they can put together. It would be good that the OPP can have specific community messaging. This is a huge undertaking and a lot of dedicated hours. Jeff will take it away and see what kind of strategy they can develop on their end.

Sara will provide Heather with a matrix on strategic plan.

➤ Policies

Heather will bring back for next meeting, as the policies were not ready. Jeff will develop wording for the policy on the found, stolen and seized money. The next meeting the policies will include:

- Travel & Per Diems

The Board agreed that all policies can come forward without the Found, Stolen or Seized Money and Found, Stolen or Seized Property which requires further review.

➤ Data Collection (how data is collected)

At the May 25th meeting, the Board requested the Detachment Commander to schedule some time to understand how the data is collected. The Board would like to have a base level understanding of how the stats are gathered. The Commander noted that this is best spoken to by MPB when they come to present the billing.

9. Other Business

Stop Signs - Member Canfield requested that the City look into the two stop signs at Westland Insurance/Post Office corner. Since the realignment of First and the installation of the roundabout the stop signs may not be relevant for traffic flow any longer. Heather will communicate with the Director of Engineering for their professional opinion.

Zone 1 Update – Member Dave Canfield attended the Zone 1 conference in September on behalf of the Board. There was a presentation on overview of detachment boards. 74% of members are OPP boards. The government is going to prescribe a minimum you have to pay for remuneration for Boards and going to put the guidelines in place. The roles and responsibilities training will be mandatory and will be online training along with the budgeting for municipal service boards. Section 31 boards will be done separately. Tom Gervais reported that there is no mandate for OPP boards to do a strategic plan but there is for municipal boards. Kenora's structure for the new board will be 7 members, 3 appointed by Council and one provincial rep.

They are looking for a secretary for Zone 1 as Debra wants to step down. Brian McKillop, Regional OPP Director talked about changes in the Act and perceptions and mentoring leaders. Bail reform is still a huge issue and finding ways to keep the dangerous offenders behind bars. Opening another class in the police college to train more officers.

Phone scams are huge such as Amazon, Canada Revenue agency and online ad sites. It was questioned if there were any discussions around costing formula and Member Canfield indicated there was not.

Kenora is hosting KDMA conference and we are organizing the speakers and wondered if OPP should be speaking. The Chief Superintendent could attend and talk about strategies.

10. Statistical Reporting – Resolution #3

Moved by A. Poirier, Seconded by & D. Canfield & Carried: -

The May-August 2023 report was presented by Detachment Commander Duggan. The report was broken down into each month and a summary. There are no deviations in crime stats. The year-to-date category highlights are the costings, the 2024 annual billing statement is out and Jeff has a tool to look at how much the categories are costing us. There are certain calls for service that are costing more than others and they will continue to ensure that the data is where it needs to be. Jeff is talking about how they can present that information to the Board.

Foot patrol hours were 948 hours from May to August. The community sees this as beneficial and there was a lot of positive comments about that. 39.5 bike patrol hours. Marine patrol hours were 18.5 hours allotted to City. 368 hours for all bodies of water.

Marine patrol hours for City of Kenora is tagged to City when it is close to town, Coney Island, Yacht Club, fireworks.

January to September 2022-2023 comparisons crime report was also presented and reviewed by the Board.

The Kenora Police Services Board reviewed the former policies in draft format and recommended approval to two policies, the Use of Board Resources Policy #KPSB-4-1 and the Travel and Per Diem Policy # KPSB-1-1.

Purpose

This policy provides direction on the appropriate use of Board resources during an election campaign.

The policy is intended to:

1. Ensure compliance with the Municipal Elections Act, 1996;
2. Ensure candidates and registered third parties are treated fairly and consistently.
3. Support the integrity of the election process.

Principles

In compliance with the Municipal Elections Act, 1996, public funds are not to be used for election campaigns, including the promotion of or opposition to the candidacy of a person for an elected office, or in support of or opposition to a question on a ballot.

Board resources including facilities, infrastructure, equipment, supplies, services, staff or any resource that belongs to or is funded by the Board may not be used for the purposes of an election campaign or for any campaign-related activities.

Policy Statement

1. Use of Board Facilities

A candidate or registered third party may not use Board facilities for election campaign purposes or for any campaign-related activities. Campaign signs and materials that identify a candidate may not be displayed in/at any Board facilities. Election campaign materials means those materials that promote or oppose the candidacy of a person for elected office, or that support or oppose a question on a ballot.

2. Board Events

A candidate or registered third party may not campaign or distribute election campaign materials at any event/function being hosted by the Kenora Police Services Board.

3. Board Infrastructure

A candidate or registered third party may not use any Board infrastructure and equipment for election campaign purposes or for any campaign-related activities. This includes any physical or technology systems that support the operation of the Board's

programs and services including but not limited to computer and telephone networks and applications, photocopiers, fax machines, email system, voicemail, wireless equipment, internet, intranet, smart phones, tablets and Board provided electronic devices.

4. Board Staff

A candidate or registered third party may not use the services of staff during those hours in which staff receive any compensation from the Board.

5. Supplies

A candidate or registered third party may not use Board supplies for election campaign purposes.

6. Printing/Distribution

A candidate or registered third party may not print or distribute election campaign materials using Board funds.

7. Websites/Social Media

Websites, domain names and social media sites that are funded by the Board may not include any campaign material, make reference to and/or identify any individual as a candidate or profile any slogan or symbol associated with a candidate.

8. Communications Material

The Board's communication materials, whether for internal or public distribution, cannot:

- i) Profile (name or photograph), make reference to and/or identify any individual as a candidate.

- ii) Advocate for or against a particular candidate.

(Communication materials include but are not limited to: news releases, media advisories, invitations for special events, flyers, posters, banners, brochures, newsletters, e-newsletters and social media accounts.)

9. Photographs / Videos

Photographs and videos produced for and owned by the Board cannot be used for election campaign purposes.

10. Corporate Identifiers/Logo

The corporate identifiers of the Kenora Police Services Board (i.e. crests, logos) may not be printed or distributed in election campaign material or included on an election campaign website. Links to the Board's website are permitted from a candidate's or third party's election website for the purpose of obtaining information about the municipal election or sharing Board program/service information.

11. Contact Information

The Board's email addresses, telephone numbers and facility addresses are not to be used by a candidate or registered third party as his/her their election campaign contact information.

Purpose

To provide for reasonable payment of expenses to members of the Kenora Police Services Board and Secretary in travelling to and attending approved seminars, training programs, conferences, conventions and social functions for the primary purpose of education and self-development of their role as Members and Staff of the Kenora Police Services Board, as well as for the promotion of the community.

Approval to Attend

Police Board Business:

Prior to attending any seminar, conference, workshop, convention and/or social function, Board approval shall be given by way of resolution setting out authorization for those eligible expenses and per diems that may be incurred.

Serving on Other Boards/Associations/Organizations:

In such cases where Members are elected or appointed to serve on District Boards, Associations and/or related Organizations, the Member shall utilize the travel policy of such Board, Association or Organization, should such policy exist. The City of Kenora will only approve expenses in accordance with this policy provided such Board, Association or Organization does not also pay it. Such approval by the Board shall be sanctioned by way of resolution to an upset limit of ten (10) days with any additional days also requiring approval by resolution of the Board.

1.0 Conferences, Conventions, Seminars

- 1.1 Full registration fee costs will be paid for each Member attending an approved event by resolution of the Board.
- 1.2 Meals and miscellaneous costs associated with travel such as taxis, parking, and other fares to a maximum limit as authorized by the Board shall be reimbursed to the Member. Reimbursement of expenses incurred in excess of maximum limit shall be made if accompanied by receipts and deemed to be in the best interests of the Board. Meal allowances are paid in accordance with the City's Business Travel & Conferences Policy HR-2-7-2. Meals included in the conference registration fee will not be reimbursed.

- 1.3 Per diem(s) will be paid for attendance at conferences and seminars in accordance with the established per diem rates established by Council's Remuneration Annual Bylaw. A full day rate is established at excess of more than 3.5 hours on a given day. A half day is established to mean a length of time from (0) to three and a half (3.5) hours on a given day.
- 1.4 The cost of economy airfare and related ground transportation will be covered, if approved by Board resolution. By vehicle, the lesser of approved mileage allowance or return economy fare will be paid. The rates are established in accordance with City's Business Travel & Conferences Policy HR-2-7-2 and the rates as set out by the Canada Revenue Agency from time to time.
- 1.5 Health Insurance premiums for basic health care insurance coverage while travelling outside of Canada will be covered, if approved in advance by the Board.
- 1.6 Mileage rates will be paid to Board Members and Secretary on an as required basis for out-of-city business only with the use of a personal vehicle. Mileage is paid based on the City of Kenora's rates established by City's Business Travel & Conferences Policy HR-2-7-2.
- 1.7 Wherever possible, use of the City's travel vehicle is to be used for travel purposes.

2.0 Social Functions

- 2.1 Reimbursement of related costs associated with a Board member's attendance at a special function on behalf of the Board in an official capacity, will be provided with Board approval in advance of the event.

3.0 Responsibilities

- 3.1 The Board shall ensure sufficient funds are included in the annual budget allocations for Board approved convention, seminar, conference and social functions. Annual operating budgets are at the full discretion of Council with recommendation by the Board to Council.
- 3.2 The Board shall approve a list of conferences, seminars, conventions, and social functions deemed to be in the best interest of the Board for the Chair, Members and Secretary to attend the prior year to meet the City's annual operating budget cycle.

- 3.3 The Board may also consider requests for attendance by the Board members and Secretary to attend conferences, seminars, conventions, and social functions not previously approved by way of an agenda item and further resolution of support by the Board, budget dependent.
- 3.4 Expenses incurred for any companion accompanying a Member or Secretary may be paid in advance by the City, however any such advance payment must be reimbursed to the City on the Member or Secretary's travel claim for any aspect of the companion's travel expenses.
- 3.5 Travel expense claim forms must be submitted for approval within ten (10) days of the last expense being incurred. The form used shall be the City of Kenora's Travel Expense Claim Form.
