#### **Call to Order**

Mayor Canfield called the meeting to order and Councillor Smith delivered a blessing.

# **Deputations**

#### Chris Madison/It's a Dog's Life - Waiving Recreation Centre fees

Chris Madison from It's A Dog's Life presented before Council to request the City of Kenora to waive the two day rental fee for the Kenora Recreation Centre on June 3<sup>rd</sup> and 4<sup>th</sup> 2016. The rental cost for these two days is \$1,243.00 plus tax.

Ms. Madison provided Council with a brief background on our organization and explained their mandate and how it has changed over the last eight years. It's A Dog's Life was formed in response to the closure of the OSPCA facility in Kenora. They operate by a dedicated group of volunteers as there is no shelter in Kenora and all their dogs live in foster homes until they are adopted.

On February 1<sup>st</sup>, 2008, It's A Dog's Life took its first dog from the pound. Since then they have brought 1082 dogs into care. Of those dogs approximately 400 of those dogs came from the pound. The remaining dogs have come from communities around Kenora. Their original mandate was a simple one. They were to take dogs that would otherwise be euthanized from the pound and place them in foster homes until they could be adopted. Today their focus has truly expanded and they now take dogs from the pound and also from surrounding communities as the need arises. They also now provide spay and neuter assistance as funds allow to help low income families; are active on Facebook to advertise dogs that have gone to the pound through Pet Patrol and the It's A Dog's Life Facebook pages; provide volunteer opportunities for students requiring volunteer hours we have over 100 volunteers that help in different capacities, some are summer residents; provide an outreach dog feeding program; educate the public on animal welfare which includes attending schools to speak to students, fun agility events, and part of program at St. Louis & Beaver Brae schools is to bring dogs and puppies when during exams and testing. They also provide after hour assistance for dogs found when animal control is not available; provide emergency vet assistance to injured dogs found in Kenora; take puppies found by animal control as the pound is not able to accommodate puppies under 12 weeks old; provide temporary assistance to families who cannot keep their dog.

The alternative to dogs not claimed by their owners from the pound is It's A Dog's Life or euthanasia. The cost per dog is \$150.00 per dog to be euthanized. It's A Dogs' Life has taken approximately 400 dogs in eight years from the pound. The cost savings to the City for this service that they provide is approximately \$60,000.00 over an 8 year period.

Below are the statistics for dogs that were at the pound and the Gifted dogs are the dogs that came into our care. Statistics for 2008, 2009 and 2010 were not available from animal control. Statistics include: 2011 the City had 141 dogs impounded with 63 of those claimed and 78 of them given to It's a Dogs Life. In 2012 the City had 148 dogs impounded, of those, 89 were claimed and 78 gifted to It's a Dog's Life. In 2013 the City had 143 dogs impounded with 99 being claimed and 37 being gifted. In 2014, the City had 100 impounded, 66 claimed and 26 going to It's a Dog's Life. In 2015 the City had 84 impounded, 49 claimed and 31 gifted.

Council thanked Ms. Madison for her deputation and a copy was left with the Clerk.

# Jon Pitcher/Trans Canada Pipelines – Presentation update on Energy East-Valves

Mr. Jon Pitcher and Ms. Tammy Manz from Trans Canada Pipelines presented an update on the Energy East project. They presented Council with where Trans Canada is at in the regulatory process and talk about the work they have done with valve placement.

One of North America's Largest Natural Gas Pipeline Networks with 68,500 km of pipeline, 20% of demand. They are the third Largest Natural Gas Storage Operator. They are the largest Private Sector Power Generator in Canada with 19 power plants, 11,900 MW, incl. 8 solar facilities (86 MW) in Ontario. They are the premier oil pipeline system with 2.5 million bbl/d ultimate long-haul. The demand in Canada for oil is Global energy demand is expected to increase 32% by 2040. Oil remains largest source of energy and the primary shift in supply mix to natural gas and renewables.

With regards to the connecting Canada project, Trans Canada is investing \$15.7 billion in private investments. No tax dollars are being invested in the project. 4,600 km length of 42" pipeline from Alberta to New Brunswick and 1.1 million bpd – total capacity. 14,000 jobs are provided during development & construction with \$55 billion GDP added to the economy and \$10 billion in additional taxes.

Trans Canada timelines for the project include: October 2014: Project Application submitted to NEB, 2015: Changes to routing and facilities; Dec 2015: Application Amendment submitted to NEB; Finalized routing of the project; Pump station locations; Valve siting methodology & locations; 2016-2018: NEB Hearing Process & Cabinet Review; Building our emergency response plans in partnership with local communities; Continue to work with local communities to address questions and concerns; 2018: Construction commences; 2021: Commissioning & In Service.

The Ontario Energy Board Report Highlights include: Greenhouse Gas Emissions (Navius Research). "A large portion of the pipeline capacity is filled with extraction that would have occurred regardless of the project's approval. As a result, the project's approval does not affect production from these resources. The pipeline simply changes the mode of transport for these resources (from rail to pipeline)." "Emissions from oil transport actually decline due to the Energy East project." Natural Gas Supply & Pricing Agreement with local distribution companies (August 2015). Pipeline Safety & Natural Environment.

They outlined the safety aspects of Trans Canada and delivering energy safely. They are committed to the environment. They protect the environment and the communities along their pipeline. TransCanada spends approximately \$1 billion each year on maintenance and integrity programs. Trans Canada monitors the lines 24/7 from the control centre in Calgary, to aerial patrols, to ground personnel and they continuously monitor and can take immediate action. In 2014, TransCanada conducted over 120 emergency drills and exercises. Consultations with local emergency responders along the Energy East route are underway. There are many safety measures in place to protect pipelines: Cathodic protection; Using an abrasion resistant external coating; Depth of cover (at or exceeding code); X-Ray inspected welds; High quality steel and In-line inspections. These measures and practices are in place to keep pipelines operating safely every day. Prevention and protection of sensitive areas, including surface and groundwater, is further achieved by: Using heavier walled pipe at water

crossings; HDD at appropriate water crossings; Strategically placing valves to reduce potential outflow volumes; Developing and practicing comprehensive Emergency Response Plans; Regular aerial patrols along entire route; 24/7 monitoring from our control centre with highly trained specialists.

Valves are placed at pump stations and intervals along the line for maintenance and protection of sensitive areas and isolation of the system to support operations sensitive areas include: populated areas, potable water sources, major water crossings, water wells, ecologically and archeologically sensitive areas, municipal water intakes, commercially navigable water. They always do worst case assumptions for conservative valve placement. Since 2014 we have added two additional valves in the Kenora area. In upstream of Kenora they have added two additional valves. Topography is important and they ensure where they place them is the safest location.

# **Bring Back OPP Helicopter to the North**

Whereas in April of 2015 the OPP search and rescue helicopter was redeployed from Sudbury to Orillia; and

Whereas since the announcement of the redeployment was made, concerns have been expressed over the protection of people in the North, as the response time from Orillia is increased by a minimum of one hour to Sudbury; and

Whereas Orillia is located in a snow belt and helicopters are allegedly not always able to fly in an emergency as a result of the weather conditions; and

Whereas many areas in the North can only be accessed by air in a more timely manner; and

Whereas faster response times can mean the difference between life and death in certain conditions; and

Whereas results of a review of the decision to move the OPP search and rescue helicopter from Sudbury to Orillia have not yet been made available and the helicopter remains in Orillia;

Therefore Be It Resolved that the City of Kenora respectfully requests that Premier Kathleen Wynne and Minister of Community and Correctional Services Yasir Naqvi expedite the return of the OPP search and rescue helicopter to the North to better serve the needs of Northern communities; and further

That a copy of this resolution be forwarded to the Honourable Kathleen Wynne, Premier of Ontario, the Honourable Yasir Naqvi, Minister of Community and Correctional Services, Bob Nault, MP Kenora, Sarah Campbell, MPP and Northwestern Ontario Municipal Association.
