# Deputations

#### Teika Newton, Kenora Refugee Support Partnership (KRSP)

The Kenora Refugee Support Partnership (KRSP) is happy to announce that they have identified a refugee family who they have offered to sponsor and help settle in Kenora. At this time, the group is asking Council to consider the merits of the efforts to resettle these refugees in Kenora, and if they have Council's support, they are asking that Council please consider providing a public statement of support for the initiative.

Kenora has welcomed refugees many times in the past, usually through private sponsorships from individual church groups. KRSP represents the first time, to our knowledge, that there has been a true community effort that combines the good will and hard work of interested citizens from many faith groups who have joined together to support a larger sponsorship effort.

In the first week of January, the sponsorship agreement holders were able to release a list of new, eligible refugees to the sponsoring groups and from this list KRSP selected a family of four Syrian refugees. The family is currently undergoing medical screening in a refugee camp in Jordan and we are awaiting notice that they have accepted the offer of sponsorship.

The father is 38 and is a telephone line repairman. The mother is 29 and is a kindergarten teacher. They have two children: a son who is 6 and a daughter who is 1. The family speaks Arabic and not English, but there are at least three Arabic speaking residents in Kenora who have already stepped forward and offered to assist with translation. There are also community members who are interested in learning how to speak basic Arabic.

It has always been the intention to resettle either a small family and several single people, or one large, extended family – up to 8 or 9 people – because they understand that refugee resettlement goes most easily when people who are new to our country and our cultures have others from their same culture to whom they can turn for social and emotional support.

When this project started back in the fall, there was a benchmark fundraising goal established which were minimum amounts required to prove that there would be the capacity to undertake sponsorship of at least four people, bearing in mind that it is less costly to resettle families than single people. There needed to be a bare minimum of \$29,000 by December and \$40,000 by February to be able to commit to sponsoring anyone at all.

At present the group has raised \$61,000 which doesn't mean they have exceeded the amount of funds needed, nor that they have stopped fundraising. It simply means they are now in a position to be able to commit to funding specific numbers of people. The group has drafted a detailed budget for the financial commitment required to sponsor the family of four: \$29,200. If they add another four single people to the mix, they will require around \$77,000. Through the Blended Visa Office Referral sponsorship model to which they have subscribed, the federal government matches the groups' sponsorship dollars.

Now that they have identified a family to support the group has been dropped to the bottom of the sponsorship agreement holder (SAH) list. If they want to sponsor additional refugees through the United Church of Canada (UCC) as our SAH, they will have a long wait to get through the queue of community groups in Canada also vying to sponsor refugees through the UCC – a nice problem of riches, but still an impediment to our goals of resettling a small community of refugees here in Kenora. For this reason, the SAH has advised that they might want to look at privately sponsoring additional refugees. They have recommended that they ask the family they are sponsoring if they have others in their extended family or social network that need our support to be relocated here, too. Everyone is welcome to the group's regular monthly community information meeting. The next one is tomorrow night, Wednesday, January 20, 2016 at 7:00 pm at Knox United Church.

## **Community Foundation Annual Interest**

Now therefore let it be resolved that the Council of City of Kenora authorizes staff to amend the contract and to allow the LOWCF to annually use up to \$5,000 of the interest generated from the City's portion of the Community Fund to be used towards administrative costs.

#### The following was highlighted by Council:

- **1.** Councillor Smith noted that there have been some fundraisers in the community for a family in the community who lost their home over the holidays. She encouraged people to support the family if they could.
- **2.** Mayor Canfield reviewed the average increase across the province for water and sewer rates. From 2001 to 2014, municipal revenues collected from water have doubled from \$970 million in 2001 to more than \$2.16 billion in 2014. The average annual increase over that period was 6.5%. The year 2014 saw the highest annual increase since 2001 of 12.68%.
