# Information on Voting by Mayor & Council under The Municipal Act, 2001

243. Except as otherwise provided, every member of a council shall have one vote;245. Any question on which there is a tie vote shall be deemed to be lost, except where otherwise provided by any Act;

- **246. (1)** If a member present at a meeting at the time of a vote requests immediately before or after the taking of the vote that the vote be recorded, each member present, except a member who is disqualified from voting by any Act, shall announce his or her vote openly and the clerk shall record each vote;
- (2) A **failure to vote** under subsection (1) by a member who is present at the meeting at the time of the vote and who is qualified to vote shall be **deemed to be a negative vote.**

Re: Budget Amendment for Keewatin Memorial Arena Roof

## **Recommendation:**

That Council hereby approves a re-allocation of \$30,000 to be funded through the Contingency Reserves for completing the Keewatin Memorial Arena Metal Roof Installation project which has a budget of \$360,000 but requires \$383,587.18 plus an approximate \$2,500 building permit fees to complete as per lowest bid price received; and further

That in accordance with Notice By-law Number 144-2007, public notice is hereby given that Council intends to amend its 2016 Operating & Capital Budget at its September 6th, 2016 meeting for this purpose; and further

That Council gives three readings to a by-law to amend the 2016 budget for this purpose.

#### Background:

The lowest bid for the installation of a new insulated metal roof to be installed over the existing metal roof of the Keewatin Memorial Arena (KMA) is \$347,422.00, plus taxes, engineering review, consultant design, and roof permit creating an approximate shortfall of over \$40,000.00 to complete the project. The budget for the project is currently \$360,000 so an amendment request is being made for \$30,000 to fund the other project associated costs. Additional bids received are as follows:

Bid #2 363,239.00 + tax Bid #3 606,753.00 + tax

The project is part of a tender that included the roof at the Kenora SportsPlex which came in within budget, however this budget amendment is required for the Keewatin Memorial Arena portion.

The City will be seeking confirmation via Letter of Intent from the Keewatin Curling Club to confirm that the Club will be responsible for 27 percent of all associated costs for the roof replacement.

**Budget:** Contingency funds of \$30,000 from reserve in 2016.

Re: Coney Wharf Rehabilitation budget Re-allocation

### **Recommendation:**

That Council hereby approves a re-allocation of \$30,000 to be funded through the Docks and Contingency Reserves for completing the Coney Island North Shore Public Dock project, which has a budget of \$230,000 but requires \$251,300 plus tax to complete as per lowest bid price received; and further

That in accordance with Notice By-law Number 144-2007, public notice is hereby given that Council intends to amend its 2016 Operating & Capital Budget at its September 6th, 2016 meeting for this purpose; and further

That Council gives three readings to a by-law to amend the 2016 budget for this purpose.

### **Background:**

The lowest bid for the removal of existing and reconstruction of the Coney Island North Shore Public Dock project is \$251,300.00, creating a shortfall of \$21,300.00 to complete the project. The ammendment request is being made for \$30,000.00 to fund any extra costs that may be associated with the project for permits, extras or unknowns. Additional bids received are as follows:

Bid #2	295,500.00 + tax
Bid #3	310,000.00 + tax
Bid #4	314,485.00 + tax
Bid #5	399,000.00 + tax

The project does have a large funding component from both NOHFC and FedNor with a deadline of December 2017.

Work is scheduled to commence this October (pipe drilling and installation) with the remainder of the project construction starting in January and completion by April 2017. This project will span 2016 and 2017 fiscal years.


