#### Crawford Lift Station Rehabilitation Tender Award

That Council hereby approves an additional allocation of \$285,000 to be funded through the transfer of two Capital items: \$75,000 (Re-aeration Tank Maintenance) and \$210,000 (Water Main Program), for the Crawford Lift Station Rehabilitation works; and further

That in accordance with Notice By-law Number 144-2007, public notice is hereby given

that Council intends to amend its 2017 Capital Budget at its August 8, 2017 meeting to withdraw funds from the Re-aeration Tank Maintenance (\$75,000) and Water Main Program (\$210,000), to offset the cost of these works; and further

That Council give three readings to a by-law to amend the 2017 budget for this purpose; and further

That the sole bid received from Manshield (NWO) Construction, Thunder Bay, Ontario, in the amount \$567,594 (plus HST) for the "Crawford Lift Station Rehabilitation" works be hereby accepted.
