# **James Road Rate of Speed Traffic Amendment**

# **KACL Partnership Request – Edible Forest Garden**

Whereas the City is supportive of the development of community garden spaces as outlined in sections 1.3.1 and 3.23 of the Official City Plan and also states that it will help by identifying sites including city parks; and

Whereas Council supports community partnerships to pursue projects for the betterment of our citizens and visitors; and

Whereas a community garden promotes locally grown fruits and vegetables making healthy food choices more readily available to those in need in our community creating a healthy food security location; and

Whereas a community partnership with the Kenora Association for Community Living and Seeds for Change Kenora has presented an opportunity for a forest garden project located at the corner of Eighth Avenue South and Fifth Street South, locally known as the "Enchanted Forest" property;

Therefore be it Resolved that Council of the City of Kenora supports the use of this municipal property for the development of a forest garden project and deems it a suitable location for the proposed forest garden; and further

That Council supports the Community Association for Community Living (KACL) and Seeds for Change Kenora in pursing funding opportunities to move this project through various funding applications and grant opportunities.

# **Enabling Accessibility Grant Agreement Execution**
