#### **Call to Order**

Deputy Mayor Smith called the meeting to order and she delivered a blessing.

# **Declaration of Pecuniary Interest & General Nature Thereof**

Mayor Canfield then asked if any Member of Council had any Declarations of Pecuniary Interest and the General Nature Thereof pertaining to any items as follows:-

Councillor Roussin declared an indirect pecuniary interest as it relates to resolution number 14 regarding Panorama Ridge Condominium #4 and 5, water service. #### **Deputations**

#### **Bert Alcock**

Mr. Alcock was concerned that at the last Council meeting two comments were made that cause the taxpayer great concern. One was that we can't touch service and the other was that we don't have the money to buy a necessary piece of equipment. The City was formed 17 years ago and Mr. Alcock feels that our taxes have gone up continuously since then. While he agrees that there have been a lot of improvements in the City, correspondently the taxes have sky rocketed and it has reached a point where it is almost a crisis. He is concerned that most seniors have a very modest income and Council needs to be concerned with this and recognize their problem. In spite of the taxes there is still a deficiency there and he feels there are a lot of improvements to do yet. Mr. Alcock wanted to state that taxing the people in the city is not sustainable to continue. There is only one action now that the City can take to help relieve this tax burden which is to follow the example of the former Keewatin when they expanded their borders. He suggests that we get a planner that is familiar with this type of action and proceed with bringing in properties that are just outside the municipal boundary to increase the tax revenue to the City.

Mr. Alcock further added that he is requesting Council to take a look at the piece of property next to the pumping station on Veterans Drive which he feels is a disgrace. The bylaw enforcement officer could enforce them to cut weeds and thistles down and in a couple hours of machine work they could level it down and put some topsoil down and match the look of the property next to it.

Deputy Mayor Smith thanked Mr. Alcock for his presentation.
