#### **A. Public Information Notices**

#### C. Confirmation of Previous Committee Minutes

Resolution #1 - Moved by Councillor R. McMillan, Seconded by L. Roussin & Carried:

That the minutes from a Special Committee of the Whole meeting held November 28, 2016 and the last regular Committee of the Whole Meeting held December 6, 2016 be confirmed as written and filed.

#### **D. Deputations/Presentations**

#### **Staff Certification Recognition**

Council recognized City staff member Katie Gilchrist, Collections Clerk, for achieving her professional designation as a certified financial collection professional. Council thanked Katie for her commitment to the City of Kenora through professional development and a certificate was presented to her.

#### Laura Christie - Confederation College

Laura Christie presented information to Council on the Confederation College 50<sup>th</sup> Anniversary celebration. In October 1967 there were 237 students and currently there are 7,605 learners in 2016 in 9 campuses with 34,000 alumni, 80% of which remain in northern Ontario. Confederation College adds \$411.2 million to the economy of northwestern Ontario annually. 468 International students are enrolled and 495 students relocated from southern Ontario. This is a market that Confederation College is now reaching out to. The Lake of the Woods Campus has 30 staff and faculty (both full & part-time) with an annual operating budget of approximately \$700,000. Students are in our communities in clinical practices, placements and volunteer hours with local businesses and agencies. The college is bringing our community together with students, employees, alumni, retirees, community supporters and a variety of events welcoming members of the public to celebrate the rich history working with the community to prepare for and to embrace the future of Confederation College. There will be a 20th Annual Scholarship Golf Tournament – June 28th, 2017. Wednesday January 11, 2017 from 4:30-6:30 p.m. there will be an open House at the Lake of the Woods Campus.

Council thanked Ms. Christie for her presentation and a copy was left with the Clerk.

#### Wynne Degagne - Kenora Pride

Kenora Pride has been operating a yearly festival/celebration of the diversity of Kenora's LGBT2S population for the past two years now.

They have been very grateful for the opportunity to raise the LGBT2S pride flag during pride celebrations over the past two years. They are asking that Council consider keeping that flag up year round, either at City Hall, or on the Harbourfront.

At this point, no other Canadian city keeps the LGBT pride flag up throughout the year. Kenora has an opportunity to set a standard for diversity and inclusivity for the region, the province, and the entire country. A decision like this would become national news and attract positive attention to our city.

Lesbian, Gay, Bisexual, Transgender, and Two-Spirit people are a diverse and growing group, both here in Kenora and across the country. Winnipeg Pride has grown exponentially in the 30 years they have been operating, from a small festival of 250, to a huge event that sees thousands of participants from around Manitoba, and also northwestern Ontario, in

attendance each year. As Kenora Pride continues to grow, they have the opportunity to attract more and more participants, which in turn brings more tourism to the area.

Organizers of Kenora Pride have been approached by several couples who are looking either to retire or downsize to a smaller community, and want to know if Kenora is a city that is safe and inclusive to LGBT2S people. It was suggested that by raising the pride flag and flying it year round, the city would send a message of total intolerance for bigotry and violence towards LGBT people. Young LGBT people often feel the need to leave a small city like Kenora as soon as they are old enough, because they don't feel represented, or they don't have access to the resources they need. Representation is also important from a psychological perspective. Wynne referenced the opportunity for Kenora to set a standard for the rest of the nation and to consider the impact raising the pride flag, and keeping it up throughout the year.

Council thanked the delegation for their presentation.

#### **Adam Smith - Enterprise Risk Management Presentation**

Adam Smith, Special Projects and Research Office presented Council with details on Enterprise Risk Management and the system established internally to assess risk management. The details of the Risk Management policy were outlined which includes next steps to the program. Risk management and ERM, is based on the assumption that all organizations are exposed to risk in the environment in which they operate. The purpose of risk management is not to manage all risks but to consider key risks that can significantly impact the achievement of objectives and outcomes and the plans in place or that need to be in place to manage them. Implementation of an ERM program at the City of Kenora will emphasize continuous improvement and be embedded into existing decision-making strategies, corporate planning, budgeting, and departmental services. However, it will take time to develop a fully mature program and the approach will be adaptive to the risk environment of the City.

Council thanked Adam for the presentation.

## 1.2 Garrow Park Exterior Fitness Tax Receipts Recommendation:

That Council of the City of Kenora hereby authorizes the issuance of tax receipts for any donation of \$75 or greater made to the City of Kenora between January 17, 2017 and December 31, 2017, unless otherwise specified due to early project completion, to be used specifically towards the Exterior Fitness Park to be built at Garrow Park.

#### Recommendation:

That Council hereby supports the Community Foundation Grant application for a new program in the community 'Imagination Library' in partnership with the Kenora Public Library; and further

#### 1.4 Minutes of Settlement

#### Recommendation:

That Council hereby authorizes the CAO to sign the minutes of settlement for assessments made under Section 40 of the Assessment Act for the years 2013 through 2016 between 89804 Canada Ltd., Municipal Property Assessment Corporation and the City of Kenora; and further

That Council hereby approves an appropriation from the Tax Write off Reserve in the amount of \$592,840.16, less any resulting recovery related to municipal vacancy rebates for this same period, to offset the cumulative reduction in municipal tax revenues as a result of these minutes of settlement; and further

That in accordance with Notice By-law Number 144-2007, public notice is hereby given that Council intends to amend its 2016 Operating & Capital Budget at its January 17, 2017 meeting to withdraw funds from the Tax Write off Reserve; and further

That Council gives three readings to a by-law to amend the 2016 budget for this purpose.

#### **Recommendation Supported.**

**Discussion:** Council has serious concerns about the tax reserves account and this amount will almost deplete this reserve account. There will be more appeals coming and this reserve account will need to be built back up to address these appeals.

#### 1.5 NWHU Anti Contraband Campaign

#### **Recommendation:**

Whereas the City of Kenora supports tobacco excise tax increases as a proven effective means of encouraging tobacco cessation; and

Whereas contrary to tobacco industry messaging, impartial research by the Ontario Tobacco Research Unit at the University of Toronto has shown that tobacco excise tax increases do not lead to large increases in contraband; and

Whereas the City of Kenora has previously passed a City of Kenora buildings smoke-free bylaw, in addition to a smoke free beaches bylaw, and supports protection of the public from second-hand tobacco smoke, protection of our youth from tobacco industry products, and tobacco tax increases to encourage smokers to quit and to raise revenue to offset the healthcare costs of tobacco use, which are more than double the current revenue raised from provincial tobacco taxes;

Therefore be it Resolved that elected representatives and staff of the City of Kenora will have no further meetings or discussions about any tobacco-related issue with representatives of the National Coalition Against Contraband Tobacco (NCACT), the Ontario Convenience Store Association (OCSA) or individuals otherwise representing the tobacco industry; and

That the City of Kenora calls on the Minister of Finance to raise tobacco excise taxes by at least \$10/carton and to enhance enforcement activities designed to reduce the presence of contraband tobacco in Ontario communities.

#### An Recommendation Supported.

**Discussion:** Councillor McMillan is concerned about the wording in the resolution about staff or the public talking having "no further meetings or discussions about any tobacco-related issue with representatives of the National Coalition Against Contraband Tobacco (NCACT), the Ontario Convenience Store Association (OCSA) or individuals otherwise representing the tobacco industry". Councillor Smith agreed to work with the NWHU on some amended wording to come before Council on the 17<sup>th</sup>.

# 3.1 Rename McQuillan Street to Kroppy's Lane Recommendation:

That in recognition of the positive impact that the late Len Kropioski had on youth in sports in the City of Kenora Council hereby renames the street locally known as McQuillan Street, as described on Plan M15, to "Kroppy's Lane"; and further

That in accordance with Notice by-law Number 144-2007, public notice is hereby given that Council intends to adopt a by-law at its January 17, 2017 council meeting, renaming the above described road as "Kroppy's Lane"; and further

That an appropriate bylaw be passed for this purpose.

**Discussion:** This is a request that came from the community to Councillor McMillan and the community is in support of this change.

# 3.2 Traffic Amendment – Birchwood Road & Crescent Stop Sign Recommendation:

#### **Recommendation:**

That the City of Kenora accepts the asset once complete and maintains it into the future for all citizens of Kenora and visitors.

#### **Recommendation Supported.**

**Discussion:** Councillor Smith is concerned that we restrict this to Garrow Park and James confirmed that it was advised he did direct them that it had to be in Garrow Park. Overall, Council supported Garrow Park as the preferred location. James will speak with our insurers to ensure they have no concerns with this addition.

#### 4.4 Garrow Park Exterior Fitness Agreement

#### **Recommendation:**

That Council hereby authorizes the Mayor and Clerk to enter into an agreement between the Corporation of the City of Kenora and The Kenora Lions Club for an exterior fitness park at Garrow Park; and further

That three readings be given to a by-law for this purpose.

#### Mayor Canfield read a media release regarding the purchase of the mall property.

#### **Recommendation:**

That Council of the Corporation of the City of Kenora authorizes an agreement with Plaza Park Street (Kenora) Investment Inc. for the acquisition of lands known as Part of PIN 42164-0140 BEING Parts of Blocks B, C, and all of Part D Plan 344 designated as Parts 1, 2 & 3 Plan 23R-14508, to authorize an easement agreement in favour of the City of Kenora over Part 4, Plan 23R-14508, City of Kenora, District of Kenora; and further

That Plaza Park Street (Kenora) Investment Inc., has agreed to sell and transfer to the Corporation of the City of Kenora the property described above, for the sum of \$481,771.88 plus HST; and further

That the Corporation of the City of Kenora has undertaken to pay for related costs including legal fees, survey fees, and any other disbursements related to the acquisition of the abovenoted lands; and further

That three readings be given to a bylaw to execute the agreement between the Corporation of the City of Kenora and Plaza Park Street (Kenora) Investment Inc.

#### **Recommendation Supported.**

**Discussion:** Councillor Goss feels this is strategic piece of property and for the short term it will make great parking options for visitors and residents who require downtown parking.

#### 4.8 'Push for Change' Event Sponsorship

#### **Recommendation:**

That Council hereby supports the 'Push for Change' fundraising event by waiving the ice time rental charges of 2.5 hours at the Kenora Recreation Centre in the amount of \$232.33.
