## **D.** Deputations/Presentations

#### **Derrick Lamarche, OPSEU – Keeping Public Services Public**

Derrick Lamarche is one of the regional mobilizer's with OPSEU for this campaign; "We Own It". Mr. Lamarche's colleague, Mike Schram, is an OPSEU member/volunteer. They are here to present and review this resolution that speaks to their own northern concern, privatization of our public assets (Keeping quality jobs, wages, and services to help grow our economy). The campaign is built on 'We built it, We paid for it, Why selling it? - Public services is not for sale because We own it!'

A growing number of communities across Ontario and around the world are standing up against privatization. Many of these communities are even taking back vital public assets and services from private companies. When public services like health care, education, and senior care remain public, the focus is on delivering high quality services to communities. When these services are privatized, private contractors focus on making profits; this means they often sacrifice quality in order to cut costs.

Several former provincial services were cut and privatized. This meant things like loss of quality service, and with the roads/highway contract a lawsuit as a result of a very serious accident due to poor maintenance standards. Places like the LCBO have high standards and consistent training for staff to ensure alcohol is properly managed. Privatized services such as this one could result in alcohol in our communities in the hands of some that should not have and the protection of the public lessened.

Quality public services help keep your communities healthy, safe and prosperous. Mounting evidence shows that privatized public services provide lower quality for a higher price.

Council thanked the group for their deputation and a copy was left with the Clerk.

#### Jazmin Romaniuk – Indigenous Reconciliation Street Naming Request

Jazmin Romaniuk was born and raised in Kenora. She is an ethnobotanist, and received her MSc in Biology from Lakehead University extensively studying the medicinal properties of Boreal Forest Flora. She has extensive experience working within the corporate structures to effect positive change within communities. She is the founder of the NP corporation Ekinamadiwin Healing Centre with a BOD that are concerned with healing education in Northwestern Ontario. She returned to Kenora after many years of study to help her city to heal emotionally, and specifically, from a traditional plant medicine educational perspective.

She spoke of Kenora's healing journey. She watched a documentary on CBC called Colonization Road. In Kenora, Colonization Road is very short and she is here to ask that we change the name of the road to something more appropriate in reconciliation. This one little road we can change perspective of the population in general. Part of the healing is moving little by little and changing the name Colonization Road to something more appropriate that is less offensive to the history of our residential schools. We can start to teach the public on the

healing process. In kindness, she would like to request that the City agree to change the street sign Colonization road and she is asking that Kenora will be a leader in healing, and already, Kenora is on the Healing path.
