1 Call to Order

Tim Davidson called the meeting to order at 9:32 am.

2 Declaration of Pecuniary Interest

3 Approval of Minutes for October 18, 2017 Meeting

4 Business Arising

Kenricia Hotel Designation - City Administration Concerns

Lori Nelson was in contact with the provincial Heritage Outreach Consultant Bert Duclos regarding the process and ramifications of amending designation by-laws. Information was distributed to the members present. If the amendment is "significant" then the process is the same as that undertaken for the original designation which would be the case in this instance. In a subsequent conversation with CAO Karen Brown it was agreed that pursuing an amendment would not be advised. Members of Heritage Kenora agreed.

With that in mind, it was noted that moving forward more attention be paid to details in the designation bylaws In addition, Randy Jackson suggested that included with the information that goes to Council for a designation should be photographs of the heritage elements so that there is a visual record and understanding of the designation details.

Education Session for Council

Lori Nelson extended the offer to CAO Karen Brown again to present an education session to Council on heritage designations by two members of Heritage Kenora. Council is very busy at this time and it was suggested by Karen that we wait until the new Council is elected in the fall. Rory McMillan suggested that in future, if a controversial designation is coming before Council then Heritage Kenora meet with Council prior to that.

5 **CIP Applications**

Melissa Shaw reported that there was interest in the CIPs at the Small Business coffee house at Sweet. There were two businesses that indicated interest in the program, however, we have not received applications from them yet. They are: Clarion Hotel - accessibility, facade and landscaping.
