# Lake of the Woods Arts Centre Project Budget Amendment 1. Moved by R. McMillan, Seconded by D. Reynard & Carried:-

That Council hereby approves an amendment to the 2018 Capital Budget to increase the Lake of the Woods Arts Centre Expansion Project total cost to \$4,029,696, representing an increase in the budgeted cost of \$229,696; and further

That this cost increase and resulting total project cost continue to be solely funded through a combination of funding from Senior Government and donations made to this project; and further That in accordance with Notice By-law Number 144-2007, public notice is hereby given that Council intends to amend its 2018 Capital Budget at its May 4, 2018 Special Council meeting; and further

That Council give three readings to a by-law to amend the 2018 Capital Budget for this purpose.

That Council gives three readings to a bylaw to execute the funding agreement between the Corporation of the City of Kenora and Northern Ontario Heritage Fund Corporation (NOHFC) for this project.
