#### **Call to Order**

Mayor Reynard called the meeting to order and Councillor Poirier delivered a blessing.

## **Deputations**

## **Charlene Ramage, Getting Ahead Program**

Ms. Ramage thanked Council for the time to present on the Getting Ahead Program. Bridges is the umbrella that the Getting Ahead Program is under. When they started the group they went from individual to policy. With a community engagement model we evolve as a community as a whole. There is a long term funding and succession planning taking place. Ms. Ramage then introduced Denise, Rose, Maryanne and Charlene who are part of the program. Collette is the facilitator along with Judy Underwood who is also a facilitator.

They pick issues that are prevalent in Kenora and right now it is housing. Their group decided that was what they were going to work on. Ms. Ramage attended the housing forum which provided follow ups and allowed us to build a support network. We are not just in support of one person, we support Council, agencies, businesses in a just getting by world. When you are in the Getting Ahead Program, people come out of the program who were living in poverty into a middle class life. They have learned a lot and a solution which is tiny homes, not expensive to build, these are not \$330,000 homes, these are affordable homes, because of the size, the land base is smaller and they don't need a whole lot of property.

The Getting Ahead Program is in many places in Southern Ontario and many have come out of poverty because of the Getting Ahead Program. Create a new vision and path for our future story in the community.

Program that supports community as a whole and wants to help. They are asking Mayor and Council to take the bridges out of poverty training scheduled for June 6, 2019. It is important for Council to understand where they are coming from. This is teamwork and this is what we are all about. They are asking a Council member to sit on the EPIC steering committee. They are not asking for a whole lot, requesting that all future reviews of official planning documents be looked at through the economic lens of this community engagement model.

Mayor Reynard thanked Ms. Ramage for her presentation and a copy was left with the Clerk.

## Steve Garrett - Ritchie Road Aggregate Pit

The Black Sturgeon South Property Owners Association is a group of over 20 home and property owners on Ritchie Road and Lawton Drive. The purpose of the deputation is to bring attention to the concerns regarding the City of Kenora's application for a category 9 aggregate permit on Ritchie Road.

On November 21 they received notice of the application to expand the pit area almost 3.5 times, from 2.7 to 9.3 hectares. Since that time they have been in contact, as an association and as individual residents, with Northwest Forestry Services and the City of Kenora Operations to voice concerns. They are aware that the project requires MNRF approval and not City Council approval but as the decision impacts City residents and City operations they feel it is appropriate to present their opinions directly to Kenora City Council.

In 1992 a group of citizens went before JM Council when Hugh Munro Construction wanted to develop the pit and it was denied. The City has been taking materials out of this pit since 2007. The reason for expansion is they are already over the boundaries under the current permit. They have concerns with respect to the noise from operation, traffic on the road. Been in communication with Mr. Hawley and Mr. Simmons who acts as consultant with the City going forward. Have made concessions with the application, but still opposed. Feel it will affect property values and the possibility of property devaluation.

The original pit permit was for Jaffary Mellick and there was little to no residential development at that point. Since then the neighbourhood has developed with a mix of full-time and summer residents. We all place a great importance on the natural environment that surrounds us. Their initial letters have resulted in some suggested changes to the permit application and they appreciate the revisions which include removal of a planned second entrance, reduced hours, and maintaining the annual tonnage to current permit levels. However, they remain opposed to the pit expansion for a number of reasons.

While they understand that the City will not be withdrawing their application they ask that City Council and senior staff reconsider. If the application remains and is approved by the MNRF they ask for a thorough review of Ritchie Road safety conditions based on the knowledge that it is not just a rural residential road but will be used by industrial traffic for decades to come.

Mayor Reynard thanked Mr. Garrett for his deputation and a copy was left with the Clerk.

#### Ryan Haines, Black Sturgeon Water Quality Report

Mr. Haines provide a summary of year 10 on the black sturgeon water quality monitoring. As a refresher, the water quality monitoring program was in response to shortly after amalgamation there were many proposed developments for Black Sturgeon and this was one of the recommendations that came out of the report that had ongoing water quality monitoring to monitor the impacts of the developments.

The lake is in good shape, very similar to previous years and in provincial water quality parameters. There are no signs of impact to increased development.

When monitoring water quality, we look at potentially shifting from proactive to reactive. All Canadian Shield lakes are getting more eutrophic (shallower, more productive) over time. This is a natural process. However, we want to make sure that human impacts are not accelerating the process (cultural eutrophication). Phosphorous is the parameter most commonly used to determine if cultural eutrophication is taking place. Phosphorous comes from fertilizers (agriculture, golf courses), septic systems and soil erosion.

There are 54 parameters measured as part of spring turnover laboratory analysis. Looking at the full suite there was no significant changes than previous years. No significant changes when compared to results from previous years and all within the Provincial Water Quality Objectives. Dissolved Oxygen/Temperature profiles collected for all sites. No significant changes.

Zebra mussels are a concern and are knocking on our doorsteps. They can have serious impacts on water intakes. Calcium has to be high in the water for them to survive and fortunately the calcium levels on Black Sturgeon are much lower so they may be spared from them as the calcium levels are not high enough for them to survive.

There are no indications that internal loading is an issue on Black Sturgeon Lakes.

It is Mr. Haines recommendation that annual spring sampling continue, but late summer sampling session could be limited to once every five years. Baseline data from 2009, 2010 and revisited in 2014. It is better use of resources to do two sampling sessions every year. Doing an annual sampling helps capture that. Reduction from original recommendation of 10 sampling sessions every five years to one sampling session every year. To save costs and going to spring sampling sessions annually could be reduced to every 3 or 5 years than late summer deeper sampling.

What's going on in other parts of the Province? Water quality monitoring is a passive and reactive method of determining impacts of septic fields on lake health (symptom). There is always the risk that once a problem is detected through monitoring, it may be too late, it's already in the water. Some municipalities have instituted septic re-inspection programs to proactively protect the water quality of their lakes. One of the challenges is that new developments is that when septic fields are brand new and being cared for, the problem is that if they are not properly maintaining and getting them pumped out, that's where there are potential problems.

NWHU approves new septic fields and they must be installed by certified installer (Class 4). Once they are installed there is no mandatory inspections or maintenance requirements. A lot of municipalities in southern Ontario are moving towards bylaws in their communities. The Building Code Act (Section 1.10.1) authorizes the council of a municipality to pass By-laws establishing and governing sewage system maintenance inspection programs (Ontario Regulation 332/12). Muskoka Lakes is probably the gold standard protecting lakes from sewage contaminants. Summer students often hired to conduct sewage system maintenance inspections. Properties are inspected once every five to seven years. Property owners are required to submit receipts of most recent septic pump-out and education on shoreline development.
