# Charlene Kissick, Community Project Planner, All Nations Hospital Project

Charlene Kissick is the Community Project Planner for the All Nations Hospital project. She has been actively working to engage with the community on the project and has moved to virtual sessions since the pandemic. They are now moving to the summer resident engagement and will be using a virtual attendance format as well. The naming of the new hospital will be part of the public engagement process and there will be an opportunity coming in the near future for this process.

The public consultation step one was focused around the clinical portion. What services and programs do community members want to see in their hospital which took place between January and May 2020. The second step of public consultation is around site location. What is important to the community with regards to a location and the consultants have identified approximately 20 possible locations. The community will still have the opportunity to comment on the possible locations once it has been shortlisted.

There is extensive community consultation and information available to the community on the project and the process will continue.
