D. Deputations/Presentations

Kathleen Lynch, President of Confederation College

Kathleen Lynch, President of Confederation College was joined by Laura Christie, Campus Director and Evelyn O'Flaherty, Member of the Board of Directors of Confederation College.

The presentation provided Council the new strategic plan presentation Kaa-anokaatekin. They have over 7,700 students studying across 58 programs prior to COVID. The pandemic restricted the International students from attending this school year. They have over 52,000 alumni and they intend to grow their contact with their alumni students in coming years.

They serve an area of some 550,000 kms and have a vast array of programs that are available in these areas. They are currently doing some renovations to the existing campus and look forward to continuing to provide many programs at the local campus.

Mayor Reynard thanked the delegation for their presentation and a copy was left with the Clerk.

1. Administration & Finance

1.1 2020 Q4 Contracts

Recommendation:

That Council hereby accepts the 2020 October – December Contracts & Expenditures Approved report.

1.2 December 2020 Financial Statements

Recommendation:

That Council hereby accepts the monthly Financial Statements of the Corporation of the City of Kenora at December 31, 2020.

Discussion: Charlotte Edie, Manager of Finance/Treasurer advised this is the start of the year end numbers for 2020. You will still see year-end adjustments to these numbers as final invoices come in for 2020 and finance continues to make year-end adjustments to various departments. The story of 2020 variances of course are COVID. There are many areas that are under revenues and various departments expenditures are down because of the closures and staff layoffs. We did receive funding from Ministry of Municipal Affairs which will fill in the gaps in revenues where we are short in 2020.

There are not a lot of variances that have changed from November. The COVID expenses that we have been able to isolate are over \$100,000 now and that may go up as we accrue payables. Winter control maintenance we do have our November and December expenses recorded and pending any further invoices we do have 12.66% remaining in that budget. We have a positive variance of almost \$122,000 currently in the winter control department. The 2020 winter has not been a regular winter. We are a little over budget under family and social services as we did set our budgets before the DSAB and Pinecrest budget requests were received so those were under budgeted in 2020. We still do not have Pinecrest 2021 budget request so we do not know if we will be in line with their request.

Mayor Reynard questioned the water and sewer budget and when will we see the finals for revenues for 2020. There are calculations required for billing and calculations to split the revenues for 2020 revenue in for end of 2020 so hoping by end of February should have those numbers.

The COVID expenses that show in the Council budget line, it just shows under Council so it doesn't show in any other department budget to make reporting easier. It represents the City's direct COVID expenses, and not a reflection of the Mayor and Council budget. It is simply the department placeholder.

1.3 2020 & 2021 Council Remuneration Recommendation:

That in accordance with Council's Annual Remuneration Policy #CC-15-1, Council hereby establishes Council's 2020 Remuneration to be set at Mayor \$39,461 and Council \$19,802 with per diems established at \$191 effective January 1, 2020; and further

That Council's 2021 Remuneration be set at Mayor \$40,053 and Council \$20,099 with per diems established at \$194 effective January 1, 2021; and further

That in accordance with Notice By-law #144-2007, notice is hereby given that Council intends to adopt a by-law establishing Council remuneration rates for 2020 and 2021 at its February 16, 2021 meeting; and further

That the appropriate by-law be passed for this purpose.

1.4 Boards & Committees Appointments Policy #CC-14-1 Amendment Recommendation:

That Council gives three readings to a bylaw to amend the City Boards & Committees Policy #CC-14-1 to reflect changes in application review by administration; and further

That bylaw number 72-2019 be hereby repealed.

1.5 Budget Amendment – Kenora Pavilion Renovations Recommendation:

That Council hereby approves a budget amendment in the amount of \$11,520 towards the construction of an office area in the Kenora Pavilion for an OPP downtown office presence; and further

That in accordance with Notice By-law Number 144-2007, public notice is hereby given that Council intends to amend its 2021 Operating & Capital Budget at its February 16, 2021 meeting to withdraw funds from the Pavilion reserves in the amount of \$11,520 for the construction of the OPP office area; and further

That Council give three readings to a by-law to amend the 2021 capital budget for this purpose.

Discussion: This is a successful partnership with the Kenora OPP and will provide a presence in the downtown for the OPP. It provides an office space in the Pavilion and will provide a presence in an area that is needed.

Council and staff are proud of the achievements that were accomplished in 2020 despite the adversities they faced.

That the Mayor and Clerk be hereby authorized to enter into a three (3) year Agreement with Debbie's Greenhouse & Garden Centre for planting and maintaining plants and shrubs in the City of Kenora; and further

4.3 Vending Services Contract Agreement – Recreation Centres Recommendation:

That Council gives three readings to a bylaw authorizing an agreement between the Corporation of the City of Kenora and Boreal Concepts for the purpose of Vending Machine Services at the Kenora Recreation Centre & Keewatin Memorial Arena for the term of March 1, 2021 to February 28th, 2026; and further

That the Mayor and City Clerk be hereby authorized to execute the Agreement.

4.4 Investment of the Big Picture Legacy Fund to the Community Foundation Recommendation:
