#### **Presentations/Deputations**

## **Presentation – Draft 5-Year Tourism and Economic Development Strategy**

Dan Penner of Urban Systems presented the Draft 5-Year Tourism and Economic Development Strategy, giving an overview of the contents and development process. The City's existing Economic Development Plan and 5-year Tourism Strategy plans are both past their lifecycle. An Updated strategy is required to ensure City efforts in promoting tourism and economic development in Kenora are consistent with the community today and over the next 5 years. In 2018, the Municipal Accommodations Tax (MAT) was approved by Council and provides the City with new resources to invest in Tourism and Economic Development. A guiding framework is needed to ensure MAT revenues are utilized effectively, transparently and consistently.

The intent of the strategy is to provide broader direction for tourism and economic development and direct the use and allocation of MAT funds into tourism and economic development initiatives.

The 5-Year Tourism and Economic Development Strategy was developed thought a fourphase process:

- 1. Background Review and Situational Analysis
- 2. Business Investor Survey
- 3. Strategic Planning Sessions
- 4. Develop, Review and Finalize the Strategy

A Vision statement sets the overall tone for the strategy and future City efforts in promoting tourism and economic development in Kenora. The vision statement included in the strategy is "Kenora will continue to grow as a regional service center with a resilient local economy that is supported by a four-season tourism sector, high quality of life and supportive local environment for businesses and entrepreneurs".

Three pillars have been included that represent key areas of in the strategy. The first is Tourism Development with sector specific focus in growing Kenora's local tourism industry and position as a service centre for regional tourism operations. Second, economic development with focus on the growth and diversification of Kenora's broader economy,

including growth and retention of local business and building partnerships. The third, Tourism and Economic Foundations, non-sector specific areas influenced or determined by a municipality that are important to creating conditions for tourism and economic growth. Goals, objectives and tactics were presented for each pillar.

In April 2018, Council adopted a by-law to establish a municipal accommodations tax (MAT). Annual funds are dedicated for the Destination Marketing Program and remaining funds collected from accommodations are to be used to further economic development and tourism objectives. The 5-Year Tourism and Economic Development Strategy includes framework for determining how to utilize MAT revenues for tourism and economic focused projects.

The goal of the MAT is to allocate funds effectively to promote tourism and economic development. The objectives include supporting eligible projects that meet strategy goals and objectives, support eligible projects not regularly included in City budgets, identify and approve eligible projects openly and transparently and ensure investment of MAT funds yields tangible outcomes.

# Eligible projects include;

- Capital Projects including planning, design, engineering and construction costs
- Events financial support, marketing and other supports to new and existing events
- Services and Programs business supports administered by City and/or City partners
- Reserve Funds contributions to longer-term City tourism and economic focused projects

#### Ineligible projects include:

- Direct financial supports and/or grants transferred directly to an individual for-profit enterprise to subsidize existing business operations
- Direct financial supports and/or grants to community groups, non-profit organizations whose core mission does not involve tourism or economic development
- Development or renewal of core municipal infrastructure (e.g. roads, water, wastewater and drainage projects) included in the City of Kenora 5-Year Capital Plan
- Services, programs and community grants typically included in the City of Kenora Operational Budget

The 5-Year Tourism and Economic Development Strategy will inform future identification of eligible MAT projects. An initial list of proposed MAT projects has also been identified though engagement with stakeholders. City staff will compile a list of annual MAT projects for Council approval and then oversee the implementation. A work plan template has been developed for MAT project planning.

#### **Discussion:**

Council thanked Dan Penner and City staff for their efforts on the 5-Year Tourism and Economic Development Strategy. The document is a draft and once finalized will be brought forward to Council for approval.
