Business Arising from Minutes (Outstanding Items)

a) Strategic Planning Next Steps – Dan Penner & Ryan Segal - Urban Systems

The strategic plan outlines the project goals which are to engage and build consensus among the detachment commander, Council, city staff and broader community on community safety priorities. Establish a clear vision and mission statement and supporting values for the Board. Develop measurable goals and actions to address community safety concerns. Include strategies for reporting and monitoring.

All of the information that is compiled by the OPP is good information for the community. Ultimately the key strategic plan contents establishes and identifies the role and responsibility of the Board to the broader community. Objectives and actions for different policing areas in crime, traffic and waterways and strategies the OPP deliver.

The work plan for the project outlines that we are now into stakeholder engagement and community engagement over January and February 2022 and were holding off anticipating in person engagement, however, with the continued restrictions this likely is not possible.

Activities to complete are 2-3 hour planning sessions with various stakeholders include the board, Council community agencies and groups, education, healthcare and business community and neighbouring Indigenous communities.

Dan will send out a survey to establish a meeting date for the Board to meet. It is proposed to hold public meetings in the evening of February 16 & 17 for two stakeholder groups. The Indigenous stakeholders will be contacted individually to determine what is best to connect with those parties.

A three hour time slot is suggested and Dan will send the survey out to members of the Board to pick a date/time.

The community engagement with residents and seasonal residents will be done virtually. On February 1st they will release the community survey. Heather will work with Dan Penner on a press release in regards to the community survey.

The community survey will focus on the perceived comfort level with general safety and police services. The survey will be online but not public so feedback from the Board will be important for the Board to provide their feedback into the survey questions.

They are moving ahead quickly now so there will be a lot taking place in February. If there are questions from the Board reach out to Dan soon so they can be considered in the next few weeks.

Detachment Commander's Report – Resolution #4

Moved by W. Van Belleghem, Seconded by D. Canfield & Carried: -

That the Kenora Police Services Board hereby accepts the Kenora OPP November 2021 monthly report as presented.

Discussion: Acting Detachment Commander Neild noted there were 176 hours of foot patrol in November and a large increase in time in the schools. We have pushed to have

RIDE programs daily and for the month of November there were 30 ride programs in 30 days. It is a way to ensure we are being seen in public and deter impaired drivers on the roads.

In November there were 1,418 calls for service which is historically average. There has been a large increase in property crimes. There is an increase in theft under by about 30% and they are looking at operational things they could do to bring this number down.

Clearance rates are averaging close to 2020 and worth noting the month of November there was a significant increase to the number of motor vehicle accidents.

The health screening report had 31 mental health calls and 50% were diverted and this is a direct reflection of the crisis mobile response team and if didn't have that diversion that would increase the numbers to the emergency department. Wait time at the emergency department is still 2 hours and 44 minutes. This team is making a significant difference in the response to the hospital.
