# Minutes

of a Meeting of the Council of the City of Kenora held Monday, March 11, 2002 – City Chambers at 5:00 p.m.

WITH Mayor D. Canfield in the Chair, Councillor R. Lunny, Councillor D. McDougald, Councillor R. McMillan, Councillor I. Parkes, Councillor T. Szajewski, Councillor C. Wasacase, Bill Preisentanz, CAO, Paulette M. Grouda, Deputy City Clerk.

Mayor Canfield called the meeting to order and Councillor Lunny read the Prayer.

#### **CONFIRMATION OF MINUTES**

1. Moved by R. McMillan, Seconded by C. Wasacase & Carried:-

**THAT** the Minutes of the last Regular Meeting of Council of the City of Kenora held **February 25, 2002,** be confirmed as written and circulated.

Mayor Canfield then asked if any Member of Council had any Declarations of Interest with respect to any items on the Agenda. The following Declarations were made:- Councillor McDougald - Resolution No. 3.

# **DEPUTATIONS:**

# **Dorothy E. Kufflick for Bruce Kitt - Handi Transit**

Mayor Canfield advised that Council would be unable to respond to this delegation as it is a personnel issue of the Handi Transit Board. Dorothy Kufflick advised that as a Loans Officer at the Credit Union she has seen Bruce bring in many happy clients and always had a smile on his face. Dorothy said Bruce's dismissal after 7 – 10 years of employment was due to a personality clash and a difference of opinion. Bruce had been told to move furniture from one unit to another, a fact unknown by the majority of Board members. On the weekends there was no dispatcher, and Bruce had to answer the calls as well as drive the van. Dorothy advised that there have been many petitions signed requesting the Handi Transit Board to reinstate Bruce, as he is very well liked by the clients he served.

Dorothy advised that it is the City of Kenora who deposits his paycheque in his account and felt the City of Kenora should have some influence in this situation. Dorothy felt Bruce should be reinstated, as the whole matter was a conflict between Bruce and a few members of the Handi Transit Board.

#### **Emily Tacknyk-Roulston**

Emily asked Council if the money that was targeted for Rabbit Lake Road is still on the books, earning interest, and earmarked for Rabbit Lake Road, and if so the Jaffray Melick residents should be so advised.

Emily also questioned at what stage the New Municipal Act was.

Karen Brown advised that the money remains in the Downloaded Roads Reserve Fund, earning interest, and in the same account that Jaffray Melick had it in. Mayor Canfield advised that the one million dollars is there for Phase 3 of Rabbit Lake Road this summer.

### Lily Bergman

Lily spoke in support of Bruce Kitt on behalf of the Kenora Injured and Disabled Workers. Lily felt that over-booking at the Handi Transit Office is what caused the most stress for Bruce. Lily felt that Bruce had been wrongfully dismissed and should be on leave for stress or sick benefits.

#### **Dave Schwartz - LOW District Hospital Board of Directors**

The Hospital Board is requesting Council to pass a by-law banning smoking in all indoor public places and workplaces. Dave advised that there are 45,000 deaths in Canada every year due to smoking related incidents and 1,000 of them are non-smokers. Dave said he would like to see Council pass a by-law to support and enact a healthy environment for everyone living and visiting the City.
