Minutes

of a Meeting of the Council of the City of Kenora held Monday, March 25, 2002 – City Chambers at 5:00 p.m.

WITH Mayor D. Canfield in the Chair, Councillor D. McDougald, Councillor R. McMillan, Councillor I. Parkes, Councillor T. Szajewski, Councillor C. Wasacase, Bill Preisentanz, CAO, Joanne L. McMillin, City Clerk.

ABSENT: Councillor R. Lunny.

Mayor Canfield called the meeting to order and Councillor McDougald read the Prayer.

CONFIRMATION OF MINUTES

1. Moved by C. Wasacase, Seconded by T. Szajewski & Carried:-

THAT the Minutes of the last Regular Meeting of Council of the City of Kenora held **March 11, 2002**, be confirmed as written and circulated.

Mayor Canfield then asked if any Member of Council had any Declarations of Interest with respect to any items on the Agenda. The following Declarations were made:- Councillor McDougald - Resolution No. 3.

PRESENTATION TO GEORGE PARKES:

Mayor Canfield, Councillor Parkes and Chief Brinkman presented a plaque to George Parkes upon his resignation from the Volunteer Fire Department after 26 years of dedicated service to the Town of Keewatin and the City of Kenora.

DEPUTATIONS:

Emily Tacknyk-Roulston

Mrs. Tacknyk-Roulston made a comment on the burying of ashes at the Lake of the Woods Cemetery and that all ashes should be at the Cemetery and not on private property and would like to see legislation enacted in this regard.

Reference was also made to the lack of Blue Box pick-up in certain areas within the City and specifically in the area of Essex Road. Mayor Canfield stated he is confident the "new" pick-up arrangement after June 30 this year will be a better system.

Rose Carver

Mrs. Carver made reference to the scenario the City has used regarding the water meter implementation. Mrs. Carver believes this is a deceptive scenario as there are different situations where there will be a significant increase to offset those rates that are rather low.

Mrs. Carver made reference to the equalizing of telephone rates between Kenora and Keewatin and does not believe Keewatin should have been increased and that equality in the rates has not been met.

Pearl Bannister

Mrs. Bannister made reference to the issue of pesticides and herbicides and whether or not Council would be adopting a by-law to ban the use of chemicals on private property and that she originally gave the information to Council in 1998. Reference was also made to the 2,200 names listed on the petition against the use of Silver Lake and questioned whether or not there will be a change on what can and cannot be placed in this site. Mayor Canfield advised the ash, etc. is being tested on a regular basis and that it is not an environmental concern.

Councillor Szajewski noted that arrangements are being made to meet with the Northwestern Health Unit in an attempt to get a by-law prepared for the banning of pesticides and herbicides on private property.

NAVIGATIONAL AIDS SYSTEM

2. Moved by D. McDougald, Seconded by I. Parkes & Carried:-

WHEREAS Council adopted Resolution Number 13 dated April 26, 2000 setting out an Action Plan with respect to maintaining a safe navigational system for boating on Lake of the Woods within the Kenora area; and

WHEREAS the City was to have made the necessary application with the Canadian Coast Guard for those navigational aids deemed to be essential within the City boundaries on the lake; and

WHEREAS Councillor Lunny was appointed this Council's representative on the Navigational Aid Committee to review this matter; and

WHEREAS the Committee has been working closely with the Canadian Coast Guard in an attempt to enhance only those navigational aids in the main channels on the lake; and

WHEREAS the Canadian Coast Guard has offered private navigational aids to all camp owners with existing buoys; and

WHEREAS the Canadian Coast Guard has now completed its original mandate to establish safe navigational aids on the main lake channels and has confirmed it will continue to maintain these buoys on an ongoing basis to ensure safety is upheld;

NOW THEREFORE BE IT RESOLVED THAT due to the Coast Guard fulfilling its mandate to enhance the main channels of Lake of the Woods with safe navigational aids and providing a long term maintenance program; and the Council of the City of Kenora hereby revokes its earlier position concerning an Action Plan for this purpose; and further

THAT Resolution Number 13 dated April 26, 2000 be and is hereby rescinded.

THAT voluntary compliance combined with an effective communication strategy by the Northwestern Health Unit on the hazards of tobacco smoke be supported as the approach to realizing a smoke-free environment; and further

THAT the Council of the City of Kenora hereby supports the Northwestern Health Unit in its efforts to implement a smoking ban in accordance with the Health Protection and Promotion Act as part of their mandate.
