# Minutes

of a Meeting of the Council of the City of Kenora held Monday, September 9, 2002 – City Chambers at 5:00 p.m.

WITH Mayor D. Canfield in the Chair, Councillor R. Lunny, Councillor D. McDougald, Councillor R. McMillan, Councillor I. Parkes, Councillor T. Szajewski, Councillor C. Wasacase, Bill Preisentanz, CAO, Joanne L. McMillin, City Clerk.

Mayor Canfield called the meeting to order and Councillor McMillan read the Prayer.

#### **CONFIRMATION OF MINUTES**

# **DEPUTATIONS:**

#### <u>Moe Girard</u>

Mr. Girard spoke on behalf of the C.N.I.B. and some 100 blind/visuallyimpaired persons in the community regarding their licence for break open Nevada tickets not being issued.

Mr. Girard briefly outlined the main reasons why the City's Lottery Licencing Supervisor would not issue the licence:-

~ lack of CNIB volunteer members operating ticket outlet; Mr. Girard believes this is not a requirement under the gaming laws of Ontario

- no reports filed with the City; Mr. Girard stated that completed reports were offered but not accepted by the City as the City was not renewing the licence
- variety of public concerns/complaints; Mr. Girard described the concerns into some detail in two different categories
- ~ number of licences/outlets already at the Kenora Shoppers Mall; Mr. Girard believes this was a decision made by City Staff.

Mr. Girard explained C.N.I.B.'s major complaint is that the licence was originally granted and now will not be issued after the organization incurred a significant cost to establish their outlet and to set up at the Mall. He also noted that the selling of tickets has been a very good fundraiser for C.N.I.B. and the organization believes they are being penalized for their success. Mr. Girard requested Council review this situation and that the C.N.I.B. licence be re-instated.

Mayor Canfield confirmed that this matter is now being reviewed by the Gaming Commission and we're awaiting their decision on this licencing ssue.
