Navigational Aids on Lake of the Woods

Councillor Lunny gave an update on the restructuring of the buoy system on Lake of the Woods. Councillor Lunny explained the Coast Guard's mandate to provide safe navigation on the lake with the buoys and this has now been completed. However the Coast Guard's original mandate was only to enhance the main channels, and not "private" territory on the lake. The Coast Guard has addressed the issue of buoys in front of private property, and the Coast Guard will allow these to stay in place but the property owner(s) would be responsible for the maintenance. The City of Kenora will not be maintaining any navigational aids inside or outside City limits as this is not the our mandate. Councillor Lunny advised the Coast Guard will continue to maintain buoys on the main channels of the lake for safe navigational purposes.

A resolution is to be prepared for Monday's meeting addressing this matter.
