Minutes

of a Meeting of the Council of the City of Kenora held Monday, June 16, 2003 – City Chambers at 5:00 p.m.

WITH Mayor D. Canfield in the Chair, Councillor R. Lunny, Councillor D. McDougald, Councillor R. McMillan, Councillor T. Szajewski, Councillor C. Wasacase, Joanne L. McMillin, City Clerk.

Absent: Councillor I. Parkes

Mayor Canfield called the meeting to order and Councillor McDougald read the Prayer.

CONFIRMATION OF MINUTES

1. Moved by R. McMillan, Seconded by D. McDougald & Carried:-

THAT the Minutes of the last Regular Meeting of Council of the City of Kenora held **Monday, May 26,** be confirmed as written and circulated.

Declarations of Pecuniary Interest

Mayor Canfield then asked if any Member of Council had any Declarations of Interest with respect to any items on the Agenda. The following Declarations were made:- Councillor McDougald - Resolution No. 4 due to a family business.

PRESENTATION:

Mayor Canfield called upon Susan Evenden, former Pool Employee, and presented her with the Royal Life Saving Society's Rescue Award of Merit for her actions, skill and knowledge in successfully resuscitating an elderly gentlemen on June 16, 2002.

DEPUTATIONS:

<u>Lydia Harlos</u>

Ms Harlos advised she will be running for Council in this year's municipal election.

Ms Harlos questioned why the hydro and telephone bills cannot be included in the same envelope in order to save money. She also made an inquiry whether or not KMTS can tell as to who she is phoning locally?

In closing she indicated her house number is not correct and that the City should be checking house numbers, and asked how numbers are being established in the rural areas.

Emily Tacknyk-Roulston

Ms Tacknyk-Roulston advised that while she inquired about the Millership Swamp after a recent Council meeting and not in the public forum, she indicated she feels compelled to advise Council this evening that the Millership Swamp continues to flood and as of this morning there is a in that

problem in that area and that not much of the culvert can be seen. She explained she was advised by the Ministry of Municipal Affairs and Housing bring her concerns to Council and she is here looking for answers.

Councillor McDougald advised that seven beavers have been trapped in this area and the dams have been opened, however Ms Tacknyk-Roulston requested that the City take another look at the problem.

She also questioned if the province is taking half of the taxes directly from the ratepayers tax bills (education). Mayor Canfield advised it is just a redistribution of funds.

Ms Tacknyk-Roulston stated that she believes the fees and rates at the Cemetery should not be increased and objects to such an increase, stating that more and more people will just scatter their ashes than use of the services at the Cemetery.

Gerry Bozzo

Mr. Bozzo referred to docking in Norman Park at the end of Pearson Street, indicating that the Condo owners were told that they could have docking but no one else could and this was done by way of letter from the City. He indicated that he has searched information on this property at Land Titles and that there is a strict covenant on the entire Norman Park. Mr. Bozzo advised that there have been incidents of harassment from some of the residents in this area to the neighbouring properties and police reports are on file to substantiate the problems. He believes that everyone should have free use of the park.

Mr. Bozzo described the details of the covenant on the property and indicated he believes the covenant connected various parts within the Park for a reason (Plan 12428 parts 1,2,3 and 4), not by mistake.

In closing he requested Council to ensure that all private docks are removed from the land because of the covenant and that it be left as it was intended for parkland use or re-forestation.

<u>Ian Clarke</u>

Mr. Clarke suggested that the residents in the Unincorporated Areas be asked if they are in favour of what is being proposed, or to have a vote on the proposed boundary expansion on Lake of the Woods. He questioned how the double-majority for the vote would work? Councillor McMillan advised that Council is only approving the Terms of Reference at tonight's meeting and that there will not be any voting by any groups for amalgamation in the immediate future.

Pearl Bannister

Mrs. Bannister circulated information to Council on pesticides on private property and questioned if all municipal Departments of the City are aware that they are not to be spraying on municipal property? She believes that chemical use on all private properties should also be banned.

Mrs. Bannister also referred to the cost of the signage on Main Street and suggested the money be spent on the roads and sidewalks that are in need of repair rather than on these signs.
